I report on the accounts of the Charity for the year ended 31 December 2021, which are set out on pages 3 to 6

Respective responsibilities of trustees and examiner

The trustees, who are also the directors of Tilstock Bradbury Village Hall for the purposes of company law, are responsible for the preparation of the financial statements. ### 1 Accounting Policies

#### 1.1 Basis of preparation

The accounts have been prepared under the historical cost convention.

#### 1.2 Incoming resources

- i) Voluntary income is received by way of donations and sponsorship and is included in full in the Statement of Financial Activities when receivable. The value of services provided by volunteers has not been included.
- ii) Grants, including grants for the purchase of fixed assets, are recognised in full in the Statement of Financial Activities in the year in which they are receivable.
- iii) No permanent endowments have been received in the period, but these are dealt with through the Statement of Financial Activities'

#### 1.3 Resources expended are recognised in the period in which they are incurred and are allocated to the particular activity where the cost relates directly to that activity. Resources expended include attributable VAT which cannot be recovered.

Administration expenditure includes all expenditure on the charitable activity of fundraising ventures' This includes the renting and running office premises, staff salaries for administrative staff and accountancy fees.
