TRUSTEES' ANNUAL REPORT FOR 2021

The charity is an accredited branch of The Mother Church, The First Church of Christ, Scientist in Boston, Massachusetts.

The Society holds a weekly Sunday service at 10.00 am; at the same time Sunday School is normally provided for young people up to the age of 20. On the first and third Wednesdays of each month Testimony Meetings are also held, where those attending have an opportunity to share healings and experiences resulting from their study and practice of Christian Science. These services and meetings are all open to members of the public.

From January to July 2021 and following Government requirements, all services were conducted online. These have been successful and provided needed spiritual community during a particularly challenging time of the pandemic, both to our traditional attendees and further afield. Since August 2021, our in-person services were reinstated in a 'hybrid' format with simultaneous online transmission. The Wednesday services have continued online only. Both our Sunday and Wednesday services have been well attended with much positive feedback and appreciation.

The Society also maintains a Reading Room at 69 Station Road East, Oxted, which is normally open for use by the public on Monday's, Tuesday's, Thursday's & Friday's, except public holidays. The Reading Room offers a quiet sanctuary to the public and a wide range of Christian Science books and other literature, including the Bible and a selection of reference books, which are available for purchase, borrowing - or study on-site. Following Government 'lockdown' requirements during 2021, the Reading Room has either been closed, or open at other times depending on the lockdown 'Tier' but with required social distancing measures as appropriate. However, the literature service has continued via post. Since July 2021, it has been reopened to the public.

Reserves Policy: While none of our funds have been formally earmarked or designated as "reserves", it is a fact that with a small membership, our regular charitable expenditure generally (although not always) results in an annual deficit. Therefore, we are dependent on a strong cash balance and donations to sustain the charitable activities and purpose over the long term.


