Administration Governance

The Langport Town Trust is constituted by a Deed of Trust dated 7 November 2006 and is a registered Charity under number 242979. Its address is c/o Town Trust Administrator, The Town Hall, Bow Street, Langport, Somerset, TA10 9PR.

The Charity is administered by 1 Trustee which is Langport Town Council.

The Trust's bankers are National Westminster Bank PLC.

Objectives

The Objective of the charity is to benefit the inhabitants of the town of Langport in particular, but not exclusively, by the maintenance, improvement or provision of public amenities.

Main Achievements

- 1 A new Trust has been established - Landmark Langport CIO - into which the main property assets have been transferred. These assets are Langport Town Hall, The Hanging Chapel and Medieval Gateway, the Walter Bagehot Town Garden and The Ridgway Hall.
- 2 The transfer of the property above dates from 1st November 2020.
- 3 The Funds in the Bagehot Memorial Fund, held by Langport Town Trust, have been transferred from Langport Town Trust to the Langport and District History Society. There is an error relating to this in the report for 2019 which states "The process of transferring the Bagehot Memorial Fund from the Trust to the newly formed CIO, the Langport and District Friendly Society is under way.)
- 4 Langport Town Trust is now investigating the disposal of remaining assets: the car park entrance, regalia, fishing rights and remaining funds.
- 5 The aim is to dispose of the above assets and close Langport Town Trust before the end of March 2022.
- 6 COVID restrictions have restricted the number of face to face meetings. Consultation with Langport Town Council as Trustee of Langport Town Trust have been mainly 'virtual'.

Reserves Policy

The Charity's policy for determining the level of reserves is to ensure funds are retained to be able to deal with any major repair work or any other unforeseen expenses arising in the next year, together with all day to day running expenses. Unrestricted Reserves at 31 March 2021 amounted to £33612.

Statement of Trusts Responsibilities

Charity Law requires the Trustees to prepare financial statements for each financial year which show a true and fair view of the state of affairs of the Charity and its financial activities for that period. In preparing those financial statements the Trustees are required to:

- Select suitable accounting policies and then apply them consistently
- Make judgements and estimates that are reasonable and prudent
- State whether applicable accounting standards and statements of recommended practice have been followed, subject to any departures disclosed and explained in the financial statements, and prepare the financial statements on a going concern basis unless it is inappropriate to presume that the Charity will continue in operational existence.

The Trustees are responsible for keeping proper accounting records which disclose reasonable accuracy at all times, the financial position of the Charity and which enable the financial statements to comply with the Charities Act 2011. The Trustees are also responsible for the safeguarding of Trust assets and hence should take reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustee has approved the Trustee Report above and the accompanying financial statement which have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the Charities governing document, the Charities Act 2011 and Accounting and Reporting by Charities. Statement of Recommended Practice applicable to Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland. published 16 July 2014.

INDEPENDENT EXAMINER'S REPORT

TO THE TRUSTEES OF LANGPORT TOWN TRUST

I report on the accounts of the Trust for the year ended 31 March 2021, which are set out on pages 5 to 6.

Respective Responsibilities of Trustee and Examiner

The Charity's trustees are responsible for the preparation of the accounts. The Charity's Trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.
