**THE ALL SAINTS DERBY GENERAL CHARITY
TRUSTEES' REPORT
YEAR TO 31ST DECEMBER 2024**

1. The Trustees of the All Saints Derby General Charity are governed by the Charities Acts and a Scheme of the Charity Commissioners dated 17th March 2009, which superseded a previous Scheme of the Charity Commissioners dated the 22nd December 1890.

2. TRUSTEES

The body of Trustees consists of up to 9 competent persons namely the Dean of Derby and the churchwardens for the time being of the parish of All Saints (ex-officio Trustees), 3 nominated trustees appointed by the Vestry of the Parish of All Saints Derby for a term of 4 years, and up to 3 co-opted Trustees appointed by the Trustees.

Ex-officio Trustees: Dean of Derby; Very Revd Dr Peter Robinson.

Churchwardens; Karen Hair and Monica Hewitt.

Representative Trustees: Val Grahl, David MacAlister and Revd Maureen Priddin. The 3-year term of office of these trustees expires at the Parish AGM in April 2025.

Co-opted Trustee: Canon Mark Titterton.

Clerk to the Trustees: Peter Holdridge.

3. THE YEAR'S ACTIVITIES

The principal asset of the charity is 1 Queen Street, Derby. The refurbishment of the property had been completed in 2023, leaving it in a very good state of repair and ready to let. 2024 was to prove a frustrating year. The agent appointed by the charity sought to let the property. A tenant was found and a lease drafted, only for this tenant to back out on the point of signing the lease. However, a new tenant was found and a lease has been signed, which began on 6 January 2025.

In the absence of a tenant throughout the year, the charity has been obliged to pay for the insurance and utility costs of the property without being able to recover these.

In light of the expenditure incurred during the year and the absence of rental income, the trustees did not feel able to respond to any request for grants in 2024. Now that a new lease has been signed, the expectation is that grants will be paid in this year.

On 6 December, the Trust received a legacy from the estate of Richard Lees of £128,796.23. This is an interim distribution and it is expected that a modest further amount will follow when the estate is finally settled. Mr Lees was known to some of the trustees and he is remembered with fondness and with great gratitude for this bequest.

4. DISTRIBUTION OF INCOME

The Trust has always worked on the basis that income is applied for charitable purposes. In 2024 income was used to maintain the principal asset of the charity, in anticipation of this generating rental income in 2025. The legacy was received too late in the year to be available for distribution.

**NOTES RELATING TO THE FINANCIAL STATEMENTS
YEAR ENDED 31ST DECEMBER 2024**

1. Accounting policies

The following accounting policies have been used consistently in dealing with items which are considered material in relation to the accounts.

Basis of accounting

The accounts have been prepared under the historical cost convention, as modified by the revaluation of investments, and are in accordance with applicable accounting standards, and the Charities Accounting Statement of Recommended Practice (SORP 2005).

Investment of income

Investment income is accounted for in the period in which the Charity is entitled to receipt.

Income and Expenditure from property

Rents and recurring expenditure are accounted for on a daily accruals basis.

Expenditure

All other expenditure is accounted for gross and when incurred.

Investments

All investments are stated at market value at the year-end. The freehold property is valued at acquisition cost and cost of refurbishment following acquisition.

The Trustees do not consider that it would be useful to incur the cost of re-valuing the property. Any gain or loss is taken to the Statement of Financial Activities and is allocated between the unrestricted and endowment funds in proportion to the value of these funds.

2. Insurance

Under the terms of the Lease the cost of insurance of the property is reimbursable by the Tenant.

3. Restricted funds

The Funds which belonged to the Charities of Francis Goodwin and an Unknown Donor, and administered by the Trustees pursuant to a Charity Commissioners Scheme made on 5th November 1954 were until 17th March 2009 restricted to the purposes declared by that Scheme. Following the Scheme of 17th March 2009 taking effect the previously Restricted Funds have been transferred to unrestricted and Endowment Funds as appropriate.

**INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF

Year Ended 31st December 2024

I report on the accounts of the Trust for the year ended 31st December 2024 and which are set out on pages 2 to 4.

Respective responsibilities of trustees and examiner
