F) TO ENCOURAGE NEW SOCIETIES WHICH PROVIDE FACILITIES WHICH BENEFIT SUB-GROUPS OF THE VILLAGE AND CO-ORDINATE THEM INTO THE LARGER FRAMEWORK OF GROUPS. G) TO PROMOTE THESE OBJECTS BY THE WAY OF MEETINGS, EXHIBITIONS, LECTURES, PUBLICATIONS, AND ANY OTHER MEANS OF PUBLICITY. H) TO MAKE NEWCOMERS AWARE OF THE GROUPS AND FACILITIES WHICH EXIST IN THE VILLAGE AND ARRANGE ACTIVITIES TO MAKE THEM FEEL WELCOME IN THE VILLAGE.
