(G) TO ADJUDICATE ON SUCH COMPETITIONS AND TO DEAL WITH INFRINGEMENTS OF ANY REGULATIONS THAT MAY APPLY TO SUCH COMPETITIONS (H) TO COLLECT ANALYSE AND DISSEMINATE INFORMATION OF VALUE THAT MAY BE ACQUIRED BY, OR ARISE FROM THE WORK OF THE ASSOCIATION I) TO WORK CLOSELY WITH, AND AS MAY BE DEEMED APPROPRIATE FROM TIME TO TIME, TO AFFILIATE TO AND PAY DUE SUBSCRIPTIONS TO ANY OTHER NATIONAL OR INTERNATIONAL BODY TO PROMOTE SWIMMING FOR PEOPLE WITH DISABILITIES USING THE HALLIWICK CONCEPT.
