Objects: HALF OF THE INCOME SHALL BE APPLIED IN THE PAYMENT OF ANY CHARGES LAWFULLY INCURRED BY THE CHURCHWARDENS IN THE MAINTENANCE AND REPAIR AND INSURANCE AGAINST FIRE OF THE FABRIC OF THE PARISH CHURCH OF SURLINGHAM AND SUBJECT THERETO IN THE PAYMENT OF LIKE CHARGES IN RESPECT OF THE MAINTENANCE OF THE SERVICES OF THE SAID CHURCH AND OF THE FURNITURE THEREOF. IF IN ANY YEAR THE WHOLE OF THE INCOME BE NOT APPLIED THE RESIDUE SHALL BE ACCUMULATED SO AS TO FORM A FUND FOR THE EXTRAORDINARY REPAIRS, IMPROVEMENT OR ENLARGEMENT OF THE FABRIC OF THE SAID CHURCH AND FOR THAT PURPOSE SHALL PAID TO THE SAID OFFICIALS FOR INVESTMENT IN THEIR NAME.THE REMAINING HALF OR THE INCOME WILL BE DISTRIBUTED WITHIN THE PARISH FOR:A) THE RELIEF OF FINANCIAL HARDSHIP EITHER GENERALLY OR INDIVIDUALLY OF PEOPLE LIVING IN THE VILLAGE OF SURLINGHAMB) TO ASSIST IN THE PROVISION OF FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABILITY, FINANCIAL OR SOCIAL CIRCUMSTANCES WITH THE OBJECT OF IMPROVING THEIR CONDITIONS OF LIFE

Activities: Receipt of a small income from trust land which is then donated to other village and church charities in the village of Surlingham.
