Godfrey's Almshouses (Charity 254036) is constituted by a Deed of Trust and registered at 4 Crundles, Petersfield, Hampshire GU31 4PJ.

During the year Grace and Graham Fountain resigned from the board of Trustees in February 2021. The Trustees were pleased to appoint Julie and Tom Pejnovic as a Co-optative Trustees in March 2021.

The purpose of the charity is to maintain Godfrey House as six self-contained flats for elderly, needy people, primarily for members of the United Reformed Church in Petersfield or any church in the local Synod of the United Reformed Church.

It is run on an entirely voluntary basis by trustees drawn from the United Reformed Church, two of whom administer the property and the finances, on a part-time basis, with frequent contact with the others. They aim to provide convenient, comfortable, well-heated homes which the residents can afford.

In March, the trustees appointed Mr Wayne Kelly to undertake many aspects of property maintenance. During the year, a Quinquennial Survey was carried out, as well as the 5-yearly electrical safety check. An asbestos survey was also carried out, and remedial works were necessary as a result of these. A door entry system was installed to increase security.

In March 2021, we welcomed Mr Paul Ledger as the new resident of Flat 38.

The 2021 budget included a 5% allowance for voids, but as the vacancy in Flat 38 was filled early in the year, the result was a void of 1.75%. There was considerable expenditure on cyclical and routine repairs, and other major areas of expenditure were electricity, water & sewerage charges, and insurance. A legacy was received from David Monger, a previous resident, to be used for maintenance and work in the garden.

The residents' maintenance contributions, being a known and reliable income, ensure a steady cash flow situation and good budgetary control. Annual allocations to approved reserve funds, based on the Almshouse Association recommendations, facilitate both Routine and Cyclical Repairs. The Extraordinary Repairs Fund now stands at £46,377.
