(C)IN PROVIDING FINANCIAL ASSISTANCE TO ENABLE BENEFICIARIES TO STUDY MUSIC OR OTHER ARTS. (D)IN AWARDING MAINTENANCE ALLOWANCES TO ENABLE BENEFICIARIES TO TRAVEL ABROAD TO PURSUE THEIR EDUCATION. (E)IN OTHERWISE PROMOTING THE EDUCATION AND TRAINING (INCLUDING TRAINING FOR EMPLOYMENT) OF BENEFICIARIES. (F)FOR ANY OTHER CHARITABLE PURPOSE PERMITTED BY THE DEED OF TRUST OF 20 FEBRUARY 1605.
