Accounts

Trustees Annual Report for year ending 31st December 2020

During the past year we have had to switch from personal home visits and excursions to telephone based befriending because of the Covid lockdowns and restrictions.

This switch has been swift and hugely successful in terms of increasing both volunteers and clients who are contacted.

Funding for the Charity has again been successful with money having been received from Duchy Health, Big Lottery (Covid-related uptake on existing award), local Rotary, Falmouth Town Council and a number of smaller personal donations. At current rates of expenditure our Manager estimates we have sufficient funds for around three years operation. Fund raising activity is, of course, ongoing.

With regard to finances the Charity is doing well and has taken the opportunity of placing two employees onto the Furlough scheme thus saving money. Our reserve policy is that the General Fund should amount to approximately £10,000 in case of emergencies and a general contingency fund.

Basis of independent examiner's statement


