Objects: TO RELIEVE FINANCIAL DISTRESS (A) BY THE ASSISTANCE AND RELIEF OF BAPTIST MINISTERS DEACONESSES AND FULL-TIME LAY PREACHERS IN NECESSITOUS CIRCUMSTANCES OF BAPTIST CHURCHES AFFILIATED TO THE EAST MIDLAND BAPTIST ASSOCIATIONS, PARTICULARLY IN CASES WHERE SUCH CIRCUMSTANCES ARISE THROUGH ACCIDENT OF INCAPACITY.
