The object of the charity is to provide funds to support local, national and international good causes.

In normal years fund raising is carried out by organising events such as a Charity Golf Day and a Fashion Show, by supermarket collections and by donations.

In 2020-21 because of the Covid-19 pandemic and restrictions on many activities our fundraising activities were curtailed. We did however manage to hold a Charity Golf Day and members of the Club made generous donations in lieu of weekly meal expenses. We were also fortunate in gaining a large grant from the Rank Foundation Covid Recovery Fund.

Summary of the main achievements of the charity during the year

In the Rotary year 2020-2021 over £35000 was donated to good causes. The largest amount – over £25000 – was spent on the purchase of 121 laptop computers which were given to 20 local primary schools to support home learning.

Although the Club was not able to hold its annual Christmas Party for Young Carers, it did provide the children with Christmas presents and later in the year with Easter Eggs. In addition some 300 Illustrated Dictionaries were provided for Year 5 children in local primary schools, part of an annual programme supported by the three Rotary Clubs in King's Lynn.

Some of the charities which have benefited from our donations include West Norfolk Young Carers, the King's Lynn Night Shelter, the Purfleet Trust, the RNLI, the Royal British Legion, Shelter Box, Guide dogs for the Blind, Kids Out, Norfolk Hospice - Tapping House, Macmillan Cancer Care, and the Queen Elizabeth Hospital.

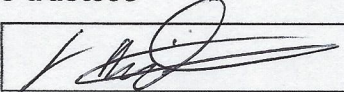
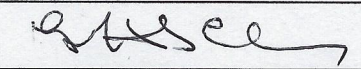
