Objects: THE OBJECT OF THE CLUB SHALL BE TO PROMOTE THE SOCIAL WELFARE OF, AND THE IMPROVEMENT OF THE CONDITIONS OF LIFE FOR, THE AGED IN ANY MANNER WHICH IS NOW, OR HEREINAFTER MAY BE DEEMED BY LAW TO BE, CHARITABLE WITHIN THE PARISH OF DRAYTON, IN THE COUNTY OF OXFORDSHIRE (HEREINAFTER CALLED THE 'AREA OF BENEFIT'). IN PARTICULAR BY UNDERTAKING THE MANAGEMENT OF THE CLUB PREMISES AND THE AREA OF LAND ASSOCIATED WITH IT, KNOWN AS THE CAUDWELL DAY CENTRE HELD UNDER THE TERMS OF AN ORIGINAL LEASE DATED 17TH JULY 1970 AND SUBSEQUENTLY RENEWED BY AGREEMENT OF THE CAUDWELL FAMILY.

Activities: To provide recreational and health care facilities for the elderly, day clubs, meals, art, whist clubs etc. Facilities for meetings and family parties. Used by village residents and visitors and guests from elsewhere but there is no restriction on this.
