Including, when deemed appropriate by the trustees, providing financial assistance, grants, sponsorship and specific payments for services received.(f) Ensure that all developments are of an improving and harmonious nature.(g) Encourage beneficial activities. (h) Communicate, by means of a Newsletter, website and social media to publicise the work of the Society and other matters of relevance to the membership and others.Changes are:3(e) Wording added to clause.
