Also, Gift Aid and Orchestra Tax Relief (claimed by the production company) are typically received after our financial year end, but are factored into our budgeted expenditure for the season; reserves allow us to do this. The Orchestra currently has higher reserves than required, and the committee has responded with the addition of a 'relaxed' concert with free tickets.

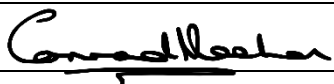

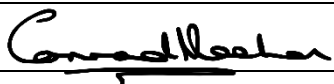

NSO Treasurer's Report

Year Ending 31 Aug 2024

Norfolk Symphony Orchestra produced five concerts during the season. Membership, Friends and ticket sales remained reasonably stable.

Ticket sales were in line with expectations, although it is noted that they remain – for most concerts – a little lower than our best pre-pandemic seasons. Ticket sales for our 'film music' concert in January 2025 were exceptionally good, however, with a total of 616 seats sold (of which 74 were free tickets for young concert-goers under 18).

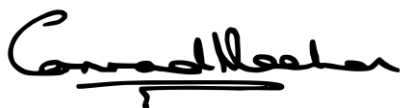
NSO has continued to benefit from a higher rate of Orchestra Tax Relief recoverable by the production company. Following a further Government announcement in the 2024 Spring Budget, NSO's future season plans now take into account the new 45% permanent rate of Orchestra Tax Relief (applicable from April 2025).

Within the season, the orchestra received a donation by way of a legacy from a former Friend of the orchestra, in a sum of just over £29,000. We are very grateful for this generous donation, which helps us to plan more confidently for future seasons.

The orchestra also received a donation of over £2300, resulting from the closure of King's Lynn Music Society. It is sad to see another local organisation, promoting the enjoyment of classical music, reach a point where it could no longer continue to operate, and we are grateful that the Society considered us a suitable beneficiary for a portion of its remaining reserves.

The orchestra ended the season with a surplus of £35,813, comprising £31,430 of exceptional items detailed above, and £4383 on our usual activities. Orchestra net assets at the end of the season were £59,958, including £46,790 cash held in our bank accounts. The committee has taken advantage of better interest rates on savings, and these significant reserves, by opening a high-interest instant-access savings account and a fixed-term savings account, maximising our return on reserves while we make plans to use them for public benefit.

Looking ahead to the 2024-25 season, we anticipate cost increases in connection with venue hire and extra musicians, and higher expenditure on soloists and music hire, and we have budgeted accordingly. We have put together a varied, ambitious and popular programme and we have good reason to be optimistic for the orchestra's medium- to long-term future.

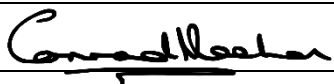

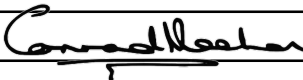

NSO Treasurer's Report

Year Ending 31 Aug 2022

Norfolk Symphony Orchestra resumed its orchestral activities in the 2021-22 season and produced four concerts. We planned the season in the expectation that revenues from membership subs, Friends' subs and ticket sales were likely to be down compared with pre-pandemic levels.

Most members have returned, and we have welcomed several new members. Membership subscription income is slightly lower than before the pandemic but above expectations.

Most of the Friends of the orchestra have continued to support NSO too. Friends donated generously to help the orchestra return to its normal activities, and the increased donation income more than offset a slight reduction in subscription income.

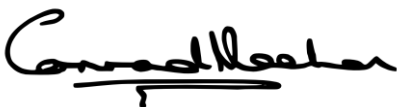
Ticket sales were lower than in previous seasons and, except for the January concert, below expectations, possibly reflecting a general reluctance amongst audiences to return to normal activities following the pandemic. For future seasons, we will need to plan based on conservative estimates of audience sizes, at least until we see signs of recovery towards normal levels.

NSO has benefited from being able to claim a higher amount of Gift Aid than usual, partly as a direct result of higher levels of donations, and partly by being able to claim on Friends' subscriptions – with just 4 concerts and lower levels of ticket sales, the average 'benefit' to Friends was within the limits permitting Gift Aid to be claimed.

NSO has also benefited from a higher rate of Orchestra Tax Relief recoverable by the production company for the May and June concerts. This is a Government measure to assist post-pandemic recovery, and the higher rate will continue into the next season before reverting to the usual rate in two annual steps.

With a surplus of £2963 for the season, reserves remain healthy. Orchestra net assets at the end of the season were £16,399, including £11,836 cash held in our bank accounts.

Looking ahead to the 2022-23 season, we hope that audience numbers will recover towards normal levels. However, we also note that the cost of living is increasing rapidly and that this may have an impact both in terms of people being willing to pay to attend concerts and in terms of the costs of producing concerts. We have therefore sought to allow for these factors in budgeting for our next season.

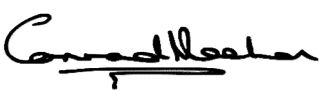
