Trustees' Report

The trustees present the annual report together with the financial statements of the charity for the year ended 31 October 2021.

Structure, governance and management

Nature of governing document

The governing document of the charity is the constitution which it adopted 13 October 1972. This has subsequently been amended, most recently in 2017.

Recruitment and appointment of trustees

Trustees were appointed by election at the Annual General Meeting. They are unpaid.

Organisational structure

During the period covered by this report The Search and Rescue Dog Association (England) was an unincorporated charity. It registered as a charity on 7 November 1972.

Objectives and activities

Objects and aims

The objective of the charity is to train air-scenting dog teams to assist for the public benefit, the police, mountain rescue teams, and any other organisation involved with search and rescue of persons missing or overdue in situations which benefit from the use of air-scenting dogs. The charity is based in England but may operate throughout England, Scotland and Wales.

Public benefit

In the furtherance of the charitable objects, the principal activities of the charity are:-

- To develop and enhance the training of search dogs, through a graded system of assessment against set criteria;
- To promote the use and effective deployment of air-scenting search dogs in England, and other parts of the British Isles as required;
- To promote methods and techniques related to the training and assessment of air-scenting search dogs to other organisations;
- To hold regular training courses throughout the year for dog teams at all stages of development;
- To provide an assessment service in order to test and verify the ability of dog teams to reach an operational standard, including in adverse conditions;
- To liaise with any like-minded organisations;
- To raise funds to promote, develop and enhance the work of the association.

The trustees confirm that they have complied with the requirements of section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission for England and Wales.

Trustees' Report

Achievements and performance

The association continued to train dogs and handlers for use when required, primarily by police forces and mountain rescue teams. The impact of Covid 19 remained, with national training and assessment being disrupted, but with pressure starting to ease. The training process continued to be locally focussed and assessment was undertaken at regional level rather than national, to minimise travel and to ease group accommodation constraints. In the coming year it is anticipated that the number of graded dog teams will increase due to clearing a backlog created by Covid 19 restrictions.

The numbers of trainees and dog teams passing assessment has largely been maintained. The number of graded handlers and dogs was 27 with 25 dogs in training and 6 unregistered puppies. Two graded dogs were lost during the year, due to one retirement and one canine medical fatality.

It is pleasing to see that the current cohort of trainees is reducing the age profile of dog handlers. The previous change in the nature of calls for assistance by mountain rescue teams continued, with an increase in minor injuries in easily accessible 'hotspots'.

We continued to see requests for dog teams to assist the police in the search for vulnerable missing persons in semi-rural settings. The number of dog callouts to 31/10/21 was 116 requiring 696 dog team hours.

In 2021 the use of drones by the statutory services for search work increased, but this is seen as another tool to enhance the effectiveness of combined search efforts, rather than replacing handlers and dogs on the ground.

Financial review

In the year to 31 October 2021 the charity's income was £35,727 (2020 - £24,510), expenditure was £24,009 (2020 - £28,425). This year there was no restricted fund income. Restricted funds of £13,902 were brought forward of which £8,044 (2020 - £9,207) was spent during the year to 31 October 2021 and £5,858 is carried forward unspent to next year. Unrestricted funds at 31 October 2021 totalled £331,318 (2020 - £311,556).

Policy on reserves


As the majority of income is from donations and legacies, the charity cannot guarantee its annual income and therefore needs to hold sufficient reserves to cope with shortfalls. The training of search and rescue dogs is long (generally 2-3 years) and once started needs to continue to its proper conclusion. With an average of 30 dogs and a working life (from grading to retirement) of about 8 years the process of training new dogs to ensure succession is continuous.

The trustees consider that the reserves are at an acceptable level to be able to provide continuity for the next four years.

Notes to the Financial Statements for the Year Ended 31 October 2021

1 Accounting policies

Statement of compliance

The financial statements have been prepared on a receipts and payments basis, as permitted under the Charities Act 2011 for unincorporated charities with a turnover of under £250,000.

Basis of preparation

Receipts, payments, assets and liabilities are recognised at transaction value.

Fund accounting

Unrestricted funds represent the accumulated funds of the charity that are not subject to any restrictions regarding their use, and are thus available in the furtherance of the general objectives of the charity. Restricted funds are income items whose use is restricted to a particular purpose and where the funds must be used in a reasonable period from their receipt.

Governance costs

These include the costs attributable to the charity's compliance with constitutional and statutory requirements, including audit, strategic management and trustees's meetings and reimbursed expenses.

Tangible fixed assets

Items of equipment are either small in value or are in effect consumables and hence are written off in the year in which they are bought.

2 Income from donations and legacies

Restricted funds comprise a development grant of £16,979 from UKSAR, of which £13,902, unspent at 31 October 2020, is brought forward. A further £8,044 of this grant was spent in the current year with £5,858 still unspent at 31 October 2021. Due to Covid 19 restrictions this grant period has been extended until March 2022.
