It was great to see the children back and give them the opportunity to play freely together after all the Covid lockdown restrictions.

Review of the charity's financial position at the end of the period	Para 1.21	The youth club holds a healthy balance at the end of the financial year due to receiving Covid recovery grants totalling £32,000 over the pandemic and not being able to operate and incur expenses.

Reserves are currently higher due to receiving Covid recovery grants but being unable to run the club. We have plans for replacing the outdoor play area fencing in summer 2022 (2,500 - £3,000), subsidising another residential trip in April 2023 (£3,000) and looking at improving the energy efficiency of the building particularly in relation to the

		heating system (£10,000 -£15,000) which will reduce our current high reserves
