Notes: The impact of the Covid pandemic continued for most of the financial year. Use of the VH was restricted for much of the year to Pre-school. As the number of children attending were lower than in previous years a 50% discount on the normal fee was agreed from September to December 2020. For the rest of the school year (to July 2021) the discount was reduced to £25%. From Sept 2021 no discount will be given.

Limited bookings returned from May (Elections, Parish Council). Although restrictions were lifted further on 19th July the majority of regular users decided they would not return until September.

Bookings, although encouraging, are not expected to return to pre-pandemic levels for some time.

With guidance from ACRE, I was able to secure further grants of £18,603 during the year which has enabled us to replace the remaining 10 windows and the 2 gas boilers. Total cost £10,397.

The Village Hall is currently in a healthy financial position and should remain so for the foreseeable future.

I report on the accounts of the charity for the year ended 30 September 2021.

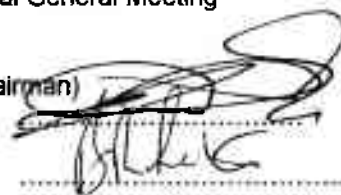

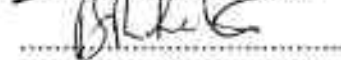
