Section B

Structure, governance and management

Type of governing document

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

How the charity is constituted

The Group is a trust established under its rules, which are common to all Scouts.

Trustee selection methods

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

Additional Governance Issues

The Group is managed by the Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As Charity Trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of 3 independent representatives, Chair, Treasurer and Secretary together with the Group Scout Leader, individual Section Leaders (where opted to take on the responsibility), and Parent representation, together with Members, who fulfil a specific function, that are co-opted. During this year of unprecedented circumstances brought about by the Covid-19 Pandemic, the Committee meet on 2 occasions and communicated electronically at other times, when Meetings were not permitted by the UK Government.

Members of the Executive Committee complete 'Essential Information for Executive Committee' training within the first 5 months of joining the Committee.

This Group Executive Committee exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for :-

- The maintenance of Group property;
- The raising of funds and the administration of Group finances;
- The insurance of persons, property and equipment;
- Group public occasions;
- Assisting in the recruitment of leaders and other adult support;
- Appointing any sub committees that may be required;
- Appointing Group Administrators and Advisors other than those who are elected.

Risk and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:-

1. Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as the church, community centre and other Scout Groups. Similar reciprocal arrangements exist with these organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.
2. Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.
3. Reduced income from fund raising. The Group is primarily reliant upon income from Subscriptions, Lettings and Fundraising. The Group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the Group on an ongoing basis, either temporarily or permanently. During 2021, the Group received Grants from HM Government, to mitigate the loss of income during Lockdowns caused by the Covid-19 Pandemic.
4. Reduction or loss of Leaders. The Group is totally reliant upon volunteers to run and administer the activities of the Group. If there was a reduction in the number of Leaders to an unacceptable level in a particular Section or the Group, as a whole, then there would have to be a contraction, consolidation or closure of a Section. In the worst case scenario the complete closure of the Group.
5. Reduction or loss of members. The Group provides activities for all young people aged 6 to 14. If there was a reduction in membership in a particular Section or the Group, as a whole, then there would also have to be a contraction, consolidation or closure of a Section. In the worst case scenario the complete closure of the Group. During 2021, there has been a slight recovery in the numbers of Youth Members but still well below the level pre the Covid Pandemic, however, the Group has retained it's level of Adult Leadership and Youth Activities continue, albeit run inline with the Guidelines applicable in this year.

The Group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include 2 signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

Scouting continued, as best it could, despite the various periods of lockdown. The leadership was more settled during 2021 but the stop/start nature of restrictions did have some impact at what is renowned to be the oldest active Scout Group in the world. The Scout Group continued to operate, with a small increase in Youth numbers, after the drop-off in 2020. The majority of the leadership team remained in post. Scouting is about preparing young people with skills for life. We have a highly skilled leadership team all of whom continued to spend additional hours of free time gaining further qualifications, undertaking mandatory training and preparing themselves to provide exciting, meaningful & unique experiences for local young people.</p>

Reserves Policy	<p>Reserves Policy</p> <p>The Group's Policy on Reserves, other than Designated Funds, is to hold sufficient resources to continue the charitable activities of the Group should income and fundraising activities fall short. The Group Executive Committee considers that a sum equivalent to 12 months normal running costs, circa £25,000, should be held.</p> <p>The Group held General Reserves of £31,835 against this at year end. 

Investment Policy
 The Group's Funds are, in the main, for the provision of Scouting for it's Members and, therefore, the Charity Trustees adopt a policy that the funds should be invested in Bank or Building Society Instant Access or Short Notice Accounts to enable the funds to be withdrawn in a timely manner. Funds designated for any major Building Work are kept in a 60 Day Notice Bank Deposit Account.
 The Scout Council's attitude to risk is that the funds generated from the Scout Council's members should be dealt with in such a way that there is no risk of loss of those funds. The Scout Council's primary aim is the provision of Scouting in the Newport and surrounding areas and not to generate additional funds by way of investment.

Plans for future periods

Despite the severe limitations on Scouting activities, due to the Covid-19 pandemic, the Group is in a positive position to re-establish its levels of youth membership and continue its high profile within the community, as the only Group on the Isle of Wight with the Freedom of its hometown.


