TRUSTEES' REPORT

The Trustees present their Report and Accounts for the year ended 31 December 2024.

REFERENCE AND ADMINISTRATIVE INFORMATION

Details are shown on page 2.

The Friends of the Royal London Hospital for Integrated Medicine is a charity registered with the Charity Commission in England and Wales.

OBJECT

The Object of the Charity is to relieve patients, former patients and staff of the hospital and other persons in the community who are sick, convalescent, disabled, handicapped or infirm and generally to support the charitable work of the Hospital. The Constitution details the powers of the Trustees.

ACHIEVEMENTS, PERFORMANCE AND FINANCIAL REVIEW

The Trustees have continued to support the activities of the Royal London Hospital for Integrated Medicine. The Accounts show net income for the year after taking account of investment movements of £2,795 (2023 £171,650). The Expenditure on Charitable Activities in the year amounted to £37,636 (2023 £12,840) including £6,148 (2023 £4,397) on requests from the Hospital towards the funding of courses and other needs and a grant of £25,000 to support the establishment of a clinic in Tower Hamlets, London by Homeopathy UK. The Total Funds at the year end amounted to £823,151. (2023 £820,356).

Reserves Policy

The Total Funds are unrestricted reserves available to cover expenditure on costs of generating funds, charitable activities and governance costs in accordance with the Object of the Charity. The Trustees have invested the assets of the Charity to generate an annual income to support the Object of the Charity. The current assets are held to cover current expenditure.

Investment Policy

The investments are managed by Rathbones Incorporating Investec Wealth & Investment (UK) under a discretionary portfolio management agreement. The Investment Managers meet the Trustees during the year to review the investments in accordance with the investment objectives of a balanced portfolio with medium risk.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The Charity was constituted by the Object and Rules dated 27 March 1975. On 3 May 2011 a new Constitution was adopted. The Constitution provides that the Trustees have control of the charity.

Appointment of Trustees/Committee Members

The Committee members are the Trustees. The Committee consists of the Chairman and between three and eleven other elected members.

Risk Management

The major risks to which the Charity is exposed, as identified by the Trustees, have been reviewed and systems are in place to manage those risks.

PUBLIC BENEFIT

In meeting the Object the Trustees have given careful consideration to the Charity Commission's general guidance on public benefit and judge that all activities meet this guidance.

STATEMENT OF THE TRUSTEES' RESPONSIBILITIES

Charity Law requires the Trustees to prepare Accounts for each financial year which give a true and fair view of the Charity's financial activities during the year and of its financial position at the end of the year. In preparing those Accounts, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether the policies are in accordance with applicable accounting standards;
- prepare the Accounts on the going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the Accounts comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent examiner's report to the Trustees of The Friends of the Royal London Hospital for Integrated Medicine:

TRUSTEES' REPORT

The Trustees present their Report and Accounts for the year ended 31 December 2023.

REFERENCE AND ADMINISTRATIVE INFORMATION

Details are shown on page 2.

The Friends of the Royal London Hospital for Integrated Medicine is a charity registered with the Charity Commission in England and Wales.

OBJECT

The Object of the Charity is to relieve patients, former patients and staff of the hospital and other persons in the community who are sick, convalescent, disabled, handicapped or infirm and generally to support the charitable work of the Hospital. The Constitution details the powers of the Trustees.

ACHIEVEMENTS, PERFORMANCE AND FINANCIAL REVIEW

The Trustees have continued to support the activities of the Royal London Hospital for Integrated Medicine. The Accounts show net income for the year after taking account of investment movements of £171,650 (2022 net expenditure £65,182). The income included a legacy of £145,313 from the Estate of James Brian Knock Deceased. Expenditure on Charitable Activities in the year amounted to £12,840 (2022 ££8,545) including £4,397 (2022 £2,723) on requests from the Hospital towards the funding of courses and other needs. The Total Funds at the year end amounted to £820,356 (2022 £648,706).

Reserves Policy

The Total Funds are unrestricted reserves available to cover expenditure on costs of generating funds, charitable activities and governance costs in accordance with the Object of the Charity. The Trustees have invested the assets of the Charity to generate an annual income to support the Object of the Charity. The current assets are held to cover current expenditure.

Investment Policy

The investments are managed by Investec Wealth & Investment (UK) under a discretionary portfolio management agreement. The Investment Managers meet the Trustees during the year to review the investments in accordance with the investment objectives of a balanced portfolio with medium risk.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The Charity was constituted by the Object and Rules dated 27 March 1975. On 3 May 2011 a new Constitution was adopted. The Constitution provides that the Trustees have control of the charity.

Appointment of Trustees/Committee Members

The Committee members are the Trustees. The Committee consists of the Chairman and between three and eleven other elected members.

Risk Management

The major risks to which the Charity is exposed, as identified by the Trustees, have been reviewed and systems are in place to manage those risks.

PUBLIC BENEFIT

In meeting the Object the Trustees have given careful consideration to the Charity Commission's general guidance on public benefit and judge that all activities meet this guidance.

STATEMENT OF THE TRUSTEES' RESPONSIBILITIES

Charity Law requires the Trustees to prepare Accounts for each financial year which give a true and fair view of the Charity's financial activities during the year and of its financial position at the end of the year. In preparing those Accounts, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- state whether the policies are in accordance with applicable accounting standards;
- prepare the Accounts on the going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the Accounts comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1. ACCOUNTING POLICIES

(a) Accounting convention

The Accounts have been prepared accordance with "Accounting and Reporting by charities: Statement of Recommended Practice" applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102 (second Edition) and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS102) and the Charities Act 2011 and UK Generally Accepted practice as it applies from 1 January 2019. The Trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

(b) Income

Investment income is accounted for when receivable. Subscriptions, Donations and the Tax recoverable on Gift Aid Donations are accounted for when received.

Legacies are included when advised by the personal representatives of an estate that payment will be made or property transferred and the amount involved can be quantified.

(c) Expenditure

Expenditure is recognised on an accruals basis.

(d) Investments

Investments are included at market value at the balance sheet date. Gains and losses on disposal and revaluation are credited or charged to the Statement of Financial Activities.

(e) Balances at Bank

Cash at Bank includes cash and short term highly liquid investments.

(f) Creditors

Creditors are recognised where a charity has a present obligation resulting from a past event and the amount to settle the obligation can be measured or estimated reliably.

(g) Fund Accounting

Funds held by the Charity are:

General funds- These funds are unrestricted and can be expended in accordance with the charitable objects at the discretion of the Trustees.
