Objects, Organisation and Activities

The object of the charity is to provide facilities for youth recreation and other leisure time occupation. This object is met by providing donations to appropriate charities and beneficiaries and by making available free of charge or on a subsidised basis, the facilities at Summers Lane for charitable purposes. The Trust has been most active in making available facilities to charitable organisations during the year; the football pitch, Astroturf facility and hall have all been used extensively during the course of the year by many charities.

Finances

The attached financial statements show the current state of affairs, which the trustees consider to be sound. The net assets have shown a decrease in the year of £3,957.

The trustees have reviewed the activities of the Trust and have concluded that there are no major risks to which the charity is exposed.

The Charity's Bankers are Allied Irish Bank and its Independent Examiner is David Harrod of Harrod Neilson & Company.

Review of Activities

The Charity continued to provide facilities and grants for the provision of sports and leisure activities to youth and community groups and in certain cases individuals.

The Trustees exercise a policy of distributing all funds generated whilst maintaining the Trusts capital for capital projects and the refurbishment of the Stadium facilities when needed. The Trustees have embarked on a major programme to refurbish the stadium, pitches, hall and boundary fences over this and next year.

The reserves of the trust are considered sufficient to continue these objectives.

Accounts

The accounts have been prepared in accordance with the accounting policies set out in the notes to these accounts and comply with the charity's Deed of Trust, applicable law and the requirements of the SORP applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102 effective January 2015).

Accounting and Reporting Responsibilities

The Charities Act 2011 requires the Trustees of the Charity to prepare financial statements for each financial year which give a true and fair view of the Charity's financial activities during the year and of its financial position at the end of the year.

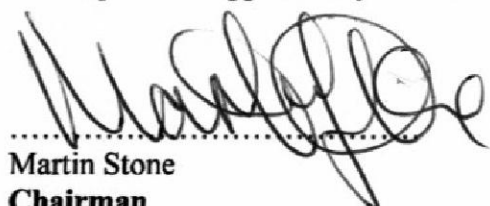
In preparing the financial statements, the trustees should follow best practice and

FOR THE YEAR ENDED 30 JUNE 2021

I report on the financial statements of the Trust for the year ended 30 June 2021, which are set out on pages 5 to 8.

Independent examiner's statement

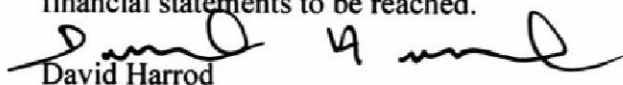
In connection with my examination, no material matters have come to my attention:

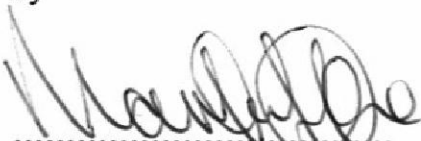

NOTES TO THE ACCOUNTS

YEAR ENDED 30 JUNE 2021

1. ACCOUNTING POLICIES

Basis of Preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities. Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

Property & Amortisation

The users of the financial statements are principally the Trustees and various donors. The trustees consider the cost of carrying out a professional valuation to include the asset at market value, an uneconomic expense compared to the limited benefit derived by users of the financial statements. Land is not depreciated. The balance sheet value of buildings is considered to be small in relation to the value of the land. Therefore, any charge for the depreciation of the buildings will not be material. The trustees consider that this policy is necessary for the accounts to show a true and fair view.

2. LONG LEASE AT SUMMERS LANE, FINCHLEY N12

On 19th July 1991 the Trustees entered into a lease with Barnet Council of the Sports ground in Summers Lane for a period of 124 years.

3. CONTINGENT LIABILITY

In 1991 and in order to provide additional finance, a loan of £145,000 was made by Bastone & Firminger Limited to Wingate and Finchley Football Club.

The terms of repayment provide that in the unlikely event that the ground at Summers Lane is sold the trustees of The Wingate Youth Trust will be required to repay the loan, subject to the Charity Commission's permission.
