2. Structure, governance and management

Wandsworth Historical Society (WHS) was entered onto the Register of Charities in October 1975.

WHS is an unincorporated organisation and is governed by its Constitution. It is run by a Management Committee, elected by its members, all of whom are volunteers. The Chair is required to retire by rotation every three years.

3. Objectives and activities

WHS' objectives, as set out in its constitution are to:

- Promote and encourage the study of local history, archaeology and related subjects in the London Borough of Wandsworth
- Put on permanent record and, where appropriate, publish the results of such study
- Coordinate local research and to guide those so engaged to sources of information
- Collect and preserve documents, pictures and other relics relating to the Borough and to encourage such preservation by official and other
- Further these objects by means of meetings, exhibitions, excavations, correspondence and visits to places of interest

The main activities undertaken for the public benefit in relation to these objective are:

- Striving to promote a keen interest among the general public in history and archaeology through monthly talks (which members of the public may attend as guests, free of charge) and the publication of high quality research via its periodic journal, the Wandsworth Historian

- Encouraging members to undertake historical research and providing support and resources via its website
- Surveying and recording the Thames foreshore from an archaeological perspective, in order to demonstrate its historical value
- Keeping its annual membership fees affordable

Having reviewed the Charity Commissioner's general guidance on public benefit, the Trustees are satisfied that these objectives continue to be appropriate.

4. Achievements for the year

WHS' achievements for the year include:

- Active involvement in and promotion of the Wandsworth Heritage Festival 2024
- A significant contribution towards the organisation and presentation of the West London Local History Conference in April 2024
- The award made to one of our Society's members by the prestigious British Association for Local History of national runner-up in its 'long heritage article' competition, following its publication in the WHS journal in the spring of 2024
- Active involvement and recognition for its important on-going local Thames Foreshore Survey, now for more than 60 years
- Active involvement in volunteering with the regional Young Archaeologists Club based at Fulham Palace
- Family Archaeological Drop-in event at Wandsworth Town Library in August 2024
- Representation on local heritage bodies including Wandsworth Heritage Forum and Wandsworth Council Conservation and Heritage Areas Advisory Committee

5. Financial Review

WHS has had a successful financial year and has adequate reserves. Its resources have been boosted by a substantial legacy from a former member. Going forward, these funds, which are held for unrestricted purposes will be used to support a series of projects to further WHS' objectives.

INDEPENDENT EXAMINER'S REPORT

Report to the Trustees of the Wandsworth Historical Society on the accounts for the year ended 31 March 2025.

Respective responsibilities of trustees and examiner
