TO PROVIDE FACILITIES, SUPPORT SERVICES, EQUIPMENT NOT NORMALLY PROVIDED BY THE STATUTORY AUTHORITIES TO BE PLACED IN THE COMMUNITY OR AT ANY MEDICAL FACILITY IN FERNDOWN AND ST LEONARDS AND THE SURROUNDING AREA.5. TO INTERACT WITH OTHER GROUPS, CLUBS & CHARITIES IN THE AREA WORKING TO SIMILAR AIMS.
