For the year ended 31 October 2023

The Trustees, who are also directors for the purposes of company law, have pleasure in presenting their report and the financial statements for the charitable company for the year ended 31 October 2023. The Trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

STRATEGIC APPROACH

Our strategic priorities and objectives are empowering the Muslim Community with essential and advanced Islamic education & skills by providing place of worship and maintaining those facilities.

MAIN OBJECTIVES OF THE CHARITY:

To advance religion for the public benefit in accordance with the tenets and doctrines of Islam.

To promote racial and religious harmony by fostering knowledge, mutual understanding, and respect for the beliefs and practices of different faiths.

To enhance the well-being of the residents of Birmingham and surrounding areas, regardless of gender, sexual orientation, age, disability, nationality, race, or political or religious beliefs. This will be achieved by uniting individuals, statutory authorities, voluntary groups, and other organizations in a collective effort to advance education and provide social welfare facilities for recreation and leisure, ultimately improving the quality of life for the community.

ACHIEVEMENTS AND PERFORMANCE

MAIN ACHIEVEMENTS OF THE CHARITY THIS YEAR:

The charity successfully continued its core activities in furtherance of its mission and objectives.

Efforts are underway to secure donations to acquire a property adjacent to the current community service location, which will further enhance the charity's offerings. The Current location of Mosque is at 17 Chapel Field E, Norwich, NR2 1SF.

Various fundraising platforms, including JustGiving and LaunchGood, were utilized, along with social media campaigns, to increase awareness and mobilise support.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

THE SOCIETY OF ISLAM IN ENGLAND is a charitable incorporated organisation (CIO) registered (number 270692) with the Charity Commission. The board of Trustees meet on a monthly basis during the year. All meetings were carried out face-to-face throughout the year. The Chair continues a process of Board development for new and established trustees. Trustees and the board of the executive committee make the decisions. The founding trustees are permanent members. Any new trustee will be appointed by existing trustees based on their willingness, knowledge and skills. There must be at least 3 charity trustees. If the number falls below this minimum, the remaining trustee or trustees may act only to call a meeting of the charity trustees or appoint a new charity trustee. The maximum number of charity trustees is 8. The charity trustees may not appoint any charity trustee if, as a result, the number of charity trustees would exceed the maximum. The day-to-day management of the organisation continues to be done by trustees.

RISK MANAGEMENT

The charity trustees have carefully assessed the significant risks the organisation faces and have implemented systems and procedures to effectively manage them. A comprehensive risk register is maintained, covering key areas such as governance, operations, finances, legal compliance, and external financial and political factors.

This risk register is reviewed at every Board meeting by the trustees and management team to ensure ongoing oversight and mitigation. Additionally, the charity maintains and regularly updates a broad range of organisational policies and procedures to proactively address and minimise potential risks.

For the year ended 31 October 2023

I report to the trustees on my examination of the accounts of the charitable company for the year ended 31 October 2023.

Responsibilities and basis of report

The financial statements have been prepared under the historical cost convention, except for investments which are included at market value and the revaluation of certain fixed assets and in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), and the Companies Act 2006.

The Society of Islam In England meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).
