Report of the Trustees

For the year ended 31st March 2025

Objects of the charity

The objects of the charity are to educate the public in old and modern shipping, and in the trades and crafts associated with shipping lore in or about Lowestoft within the Waveney district of Suffolk. The trustees have taken due regard to the guidance published by the Charity Commission regarding public benefit and consider the operation of the museum, which is open to the general public and local schools and youth groups, does indeed provide a public benefit.

Structure, Governance and Management

The charity was founded in 1958 and registered as an incorporated charity under reference 27144. The charity's constitution was adopted on 29th April 1976 and registered with the Charity Commission on 21st June 1976.

The Trustees are elected by vote, open to the entire membership. They remain in office until they choose to resign or are removed by a members vote. All Trustees sit on the committee and attend regular meetings. Upon appointment Trustees are provided with copies of:

- the charity's constitution
- the latest accounts of the charity
- Charity Commission guidance notes CC3 " The Essential Trustee"

They are also encouraged to read Charity Commission newsletters and attend appropriate training and updating courses to keep informed.

The committee is elected and comprises Trustees and society members. The committee meet monthly to manage the society. Any Trustee business is discussed prior to the formal committee meeting at which committee members are welcome to attend, but not vote. The wider membership are invited to attend the AGM and any other meetings which require a full membership vote.

The AGM is normally held on the last Thursday in June each year. All committee members stand for re-election at this AGM. The position of Trustee is separate from that of committee member and as such the Trustees do not stand for re-election at this meeting.

The Trustees and management committee are aware of potential risks facing the charity and deal with these as appropriate when they are expected to arise. There is no formal risk assessment policy, and likewise although there is no formal policy for investment management the Trustees keep an eye on the society's funds to ensure they are receiving the best return for the level of risk deemed acceptable.

Purposes and Aims

The society continues to run the museum at Sparrows Nest as a means of meeting the objectives of the charity and raising funds. The museum strives to appeal to local people and visitors alike. The success of this can be witnessed by comments to staff by visitors and local school and youth groups. Together with requests for reference material, educational aids and research from both inside and outside of the UK.

Review of Activities & Finance for the year.

This year once again brought the challenges of attracting and retaining volunteers. The age profile of the current volunteers and trustees remains an area of concern and is under constant review.


The museum opened for the season at Easter 2024 and this year saw an increase in visitor numbers, albeit only a small one. The introduction of a second donations box in the body of the museum proved successful in generating an increase in donations.

Work on updating policies and procedures was completed. It has been resolved to monitor these more regularly to avoid it becoming too onerous a task. An application to renew the museum's Arts Council Accreditation has been submitted.

The trustees remain committed to the future of the museum and take all reasonable measures to ensure it's future financial stability. They continue to maintain the funds held within the COIF account in light of the potential need to move premises or indeed close. As at 31st March 2025 the balance held within the COIF account was £253,537.

As always the museum continues to rely on the support of volunteers for its operation and the trustees wish to express their gratitude to all those who, by whatever means, enable the society to continue with its mission to preserve and educate.

1 ACCOUNTING POLICIES

a) Basis of accounting

The accounts have been prepared under the historical cost convention in accordance with the Charities Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005 and the Charities Act 2011.

b) Designated Funds

Unrestricted funds are donations and other income received as generated for the objects of the charity without specified purpose and are available as general funds.

Designated funds are amounts which have been set aside at the discretion of the Trustees for a specific, but not legally binding purpose.

c) Incoming Resources

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy.

Voluntary income is received by way of donations and is included in full in the Statement of Financial Activities when received.

Grants are recognised in full in the Statement of Financial Activities in the year in which they are received. If they are for designated purposes, they are only used for that purpose and appear under the restricted fund heading.

d) Resources Expended

Expenditure is reported on an accrual basis as the liability is incurred.

Charitable activities comprise those costs incurred by the charity in the delivery of its activities and the provision of its services to the public.

e) Fixed Assets

All fixed assets are initially recorded at cost.

Depreciation is provided on the new extension on a straight line basis to cover the period of the 25 year lease. Equipment is depreciated at the rate of 25% using the reducing balance method. Additions to the building have also been depreciated on a 25 year straight line basis.

f) Stock

Stock is valued at the lower of cost or net realisable value. The figure reported in the financial statements relates to the stock take of January 2025 and the subsequent valuation.

Grants are recognised in full in the Statement of Financial Activities in the year in which they are received. If they are for designated purposes, they are only used for that purpose and appear under the restricted fund heading.

d) Resources Expended

Expenditure is reported on an accrual basis as the liability is incurred.

Charitable activities comprise those costs incurred by the charity in the delivery of its activities and the provision of its services to the public.

e) Fixed Assets

All fixed assets are initially recorded at cost.

Depreciation is provided on the new extension on a straight line basis to cover the period of the 25 year lease. Equipment is depreciated at the rate of 25% using the reducing balance method. Additions to the building have also been depreciated on a 25 year straight line basis.

f) Stock

Stock is valued at the lower of cost or net realisable value. The figure reported in the financial statements relates to the stock take of January 2024 and the subsequent valuation.
