**Objects:** PROMOTING THE SPIRITUAL MATERIAL AND MENTAL WELFARE OF PERSONS WHO ARE MENTALLY OR PHYSICALLY HANDICAPPED AND THUS HAVE DIFFICULTY IN ATTAINING OR ARE UNABLE TO ATTAIN A NORMAL STANDARD OF EDUCATION TRAINING AND GENERAL ABILITY AND WHO BY REASON OF THEIR MENTAL OR PHYSICAL DISABILITY ARE IN NEED OF HELP OR CARE BY THE PROVISION OF SPECIAL TRAINING SHELTERED EMPLOYMENT OR OCCUPATION.

**Activities:** To receive legacies and bequests for the benefit of people with learning disabilities. To transfer all funds (less costs) to Prospects for People with Learning Disabilities. On 1 April 1997 the Charity transferred all its assets, liabilities and activities to Prospects for People with Learning Disabilities, a charity (number 1060571) and company limited by guarantee.
