We had another busy year which enabled us to raise funds not just for the Choir's work in the community, but also for CLEAR (£1,550), Cinnamon Trust (£1,550), YMCA (£400), St. Pol-de-Leon Church (£1,350) and various other local charities.

Our tour to Bristol was extremely enjoyable and well received. The recital we gave in Wells Cathedral will last long in the memory.

It has been another extremely busy and successful year. We are looking forward to the year ahead, particularly our tour to Huddersfield to sing at a couple of concerts with two excellent Male Voice Choirs and the opportunity to sing in Blackburn Cathedral.

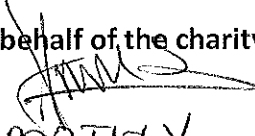
