Objectives & Activities

The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the Association should undertake.

The Association subscribes to membership of Parentkind, an organisation representing parent teacher associations with membership of approximately 12,000. The cost per annum in 2025 was £162 & provides, amongst other services, trustee insurance.

It is the policy of the Association to retain funds to meet the costs of future projects for the benefit of the school & its pupils as they arise. As at the 31st July 2025 the reserves were £19,271 (2024: £23,569). During the year to 31st July 2025 the trustees have continued to actively reduce the level of reserves held for the future, in favour of increasing the association's current support for the school, despite a slight reduction in total fundraising compared to 2024. The trustees are pleased to report that as a result the association has been able to provide total funding to the school of £21,267 during 2024/25.
