**Activities:** WMCT makes grants to voluntary organisations which promote moral education, or assist people suffering ill-health, poverty, mental or physical distress or who are in need of support in dealing with personal relationships. Beneficiaries must live within the Royal Borough of Windsor & Maidenhead.
