The fund was first set up on the death of the settlor to pay or apply the income and capital, as grants, for such charitable purposes as the then trustees should in their absolute discretion determine.

#### **Charitable Objects and the Advancement of Public Benefit**

There are no restrictions in the Will Trust itself, other than in respect of grants to individuals. In the past the former trustees gave priority to charities which existed for the benefit of causes which were of the greatest interest to the late Lord Egerton, namely:

- wildlife and the countryside, and
- children and young people particularly in the Cheshire area.

On 19 April 2011 the trustees resolved by way of grant to transfer the property of the charity, consisting of its investment portfolio and cash, to Barnardo's. They subsequently retired as trustees in favour of Barnardo's, which now administers the charity. The trustee will continue to receive, from time to time, payments in respect of releases of restrictive covenants arising from land formerly part of the Will Trust. No other assets are held, as far as the Trustees are aware.

The trustee has paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

**Responsibilities and basis of report**


