Report of the Trustees For the Year Ended 31st March 2023

The trustees present their report with the financial statements of the Charity for the year ended 31st March 2023. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable in the UK and Republic of Ireland (FRS 102) (effective 1st January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

These are defined in the constitution as being:-

To alleviate suffering and distress caused to dogs, and particular the breed known as Pointers, which may be ill-treated, abandoned or neglected.

Significant activities

The significant activities are the transportation, boarding and veterinarian needs of the dogs rescued in the year. Emergency rescue, treatment and homing of 21 dogs.

Public benefit

The Council is mindful of the Charity Commission's guidance on public benefit, and the charity is compliant with it.

Grant making

Sundry grants can be made from year to year.

Volunteers

The Charity recruits and trains volunteers to transport, foster and fundraise. We are always searching for suitable volunteers.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

The Charity continues to support rescuing pointers from Europe and in the UK. This has been supported by a good high demand for people wanting to re-home Pointers. The numbers of Pointers saved was over 60 this year, with some cross breeds, possibly half the total from Spain.

Fundraising activities

The dynamic of fundraising has changed with the appointment of a new committee member dedicated to improving our web shop and running stalls and several country shows and fayres.

Investment performance

The investment performance of the cash balances during the year has been satisfactory.

Internal and external factors

The Council are mindful of the potential internal and external factors which may affect the performance of the Charity.

The principal funding sources are voluntary donations and fundraising activities.

**Independent Examiner's Report to the Charity Commission for The Pointer Rescue Service
(Charity Number: 273168)**

For the year ended 31 March 2023

I report to the Charity Commission on my examination of the financial statements of The Pointer Rescue Service (the "Charity") for the year ended 31 March 2023.

Responsibilities and basis of report

As the trustees of the Charity, you are responsible for the preparation of the financial statements in accordance with the Charities Act 2011 ("the Act"). You consider that the audit requirement of section 144(2) of the Act does not apply, and that an independent examination is required.

I have been appointed to conduct an independent examination of the financial statements under section 145 of the Act, and to report to the Charity Commission in accordance with the Act.

My role is to state whether particular matters have come to my attention during the course of my examination, as provided in the Act. My examination is carried out in accordance with the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act. An examination includes a review of the accounting records kept by the Charity and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements and seeking explanations from you as trustees concerning any such matters. The purpose of the examination is to provide a limited assurance that no material matters have come to my attention that give me cause to believe that, in any material respect:

1. Accounting records have not been kept in accordance with section 130 of the Act; or
2. The financial statements do not accord with those records; or
3. The financial statements do not comply with the applicable requirements concerning the form and content of financial statements set out in the Charities (Accounts and Reports) Regulations 2008, other than any requirement that the financial statements give a "true and fair view" which is not a matter considered as part of an independent examination.

Independent examiner's statement

1. Which gives me reasonable cause to believe that, in any material respect, the requirements:

- To keep accounting records in accordance with section 130 of the Act; and
