Objectives and activities of the Club

Tring Tornadoes Junior Sports Club is a registered charity, an FA Development Standard club and holds the Bronze Level England Netball CAPS accreditation.

The club has the following objectives:

- The aim of the club is to help and educate children & young people through activities to develop their physical, mental and spiritual capabilities so that they may grow to maturity as individuals and members of society and that their conditions of life may be improved.
- As well as providing involvement in Football, Futsal and Netball for our members in the Tring area the club provides after school clubs and other sporting activities for members of the community.
- As coaches, our fundamental objective / responsibility is to develop a life-long love of sport and encourage participation at any level, for as long as possible.
- We continue to emphasise player development ahead of a win-at-all-costs mentality, with continued encouragement for fair play, good sportsmanship as well as effort. This is encouraged at each level, from team mates to spectators for all teams including visitors.

The club is also committed to providing education for its members, through the approved courses operated by each of the National Governing Bodies we are involved with.

Our aims & objectives are underpinned by a core set of values, that guide all of our activities and coaching judgements & playing standards:

- **Tolerance** - we're all unique and different in our own ways, whether it be in our views, opinions or abilities. We embrace the differences and take the time to understand them, using the perspectives we gain, when considering our own actions.
- **Respect** - we respect each other at all times. Our respect is extended to coaches, the opposition, supporters, referees and umpires. We treat others how we would like to be treated.
- **Inclusiveness** - we are passionate about being open and providing all children within Tring and its surrounding villages an opportunity to play sport in a fun and safe environment. All abilities are welcome. We are united in the spirit and direction of the club and its role in the local community.
- **Nobility** - we display fine personal qualities including integrity and resilience. Our intention is to leave a positive impression whilst being associated with the club and beyond, wherever we go. Sportsmanship and fairness are more important than winning.
- **Growth** - we grow and develop our players and members from both a sporting and personal perspective, enabling them to become the best that they choose to be at sport and in their contribution to the wider society.

In 2019 the members approved a change to the club constitution varying the age range for junior membership from 3-18 years old, to also include young adults. This applies across all current sports (Football, Girls Football, Futsal & Netball) and any new ones in the future, for all the young people of Tring & the surrounding villages.

Governance and Management arrangements

The club is governed by its constitution and is operated as an association. Tring Tornadoes JSC is run by a Management Committee whose members are elected in the Annual General Meeting. It meets regularly and plans the activities of the club across all sports.

The Management Committee is made up of representatives from all sports with specific roles associated to each member. The Committee meets regularly to discuss and resolve operational issues associated with running a Junior multi sports club. The Management Committee report to the Trustees who have overall financial responsibility and are generally co-opted Committee members. Trustees are appointed by the Management Committee.

Various sub-committees exist and feed back to the Management Committee. These include: facilities, fundraising, football, girls football, netball and futsal.

The club is a member of the Hertfordshire Football Association and is affiliated to the: Bedfordshire Girl's Football League; South Bucks Mini Soccer Conference; West Herts Youth League and Wycombe & South Bucks Minor Football League. The club is also affiliated to England Netball and operates teams in leagues in Aylesbury, Watford and Welwyn.

The club holds a 12.5% share (through its Trustees) in Pendley Sports Limited (a land freehold owner) and is an active participant in the running of the entity (Pendley Sports Centre Limited (PSCL)) that operates the leasehold and communal areas governance thereof. The charity holds a 125 year Lease (from PSCL) on a small amount of land with two football pitches at the top end of Cow Lane. In the long-term the club would like to secure further playing fields and suitable sporting facilities for the young people of Tring in perpetuity.

The charity does not make any grants. The charity is reliant on volunteers for all its work and no one involved in the charity is paid, other than out of pocket expenses at cost. On all significant expenditure, for example construction work, the Trustees & Management Committee signs off on work done before it is committed to and ensures that the most economically, advantageous terms for the club are pursued at all times.

Achievements and Performance

In the season 2021/22, we returned to normal club operations (post-COVID) and were able to operate our sports without restrictions. Tring Tornadoes JSC:

1. Provided sport for over 650 boys and girls.
2. Further increased participation in girls football, adding new coaches to the section and then helping them secure the necessary FA coaching qualifications to enable us to add additional match day teams to the section.
3. Sustained Netball participation at current full capacity whilst continuing to seek new playing locations in order to try and meet demand. The Netball section continues to grow, with waiting lists for all age groups. With the struggle to get more training and match facilities these lists continue to grow. We have numerous level 1 coaches and a level 2 coach, plus qualified umpires in the club.
4. Encouraged many players and volunteers to attend suitable training to teach football, netball and futsal with many obtaining recognised qualifications. These courses include child protection/safeguarding, emergency aid, referee, linesman, umpire as well as FA Level 1 and 2 qualifications.

Charitable Status

Since formation in 1970, Tring Tornadoes Junior Sports Club (TTJSC) became an Unincorporated Charitable Association in 1978 and has operated on that basis ever since.

In November 2019, at the Annual General Meeting, the resolution was passed that TTJSC would become an Incorporated Charity and that the current TTJSC Trustees (Stephen Bailey, Stuart Parker, Martin Pontoppidan and Matt Jarman) were given the mandate to take all necessary actions to achieve Incorporated Charity status. Over the period January 2020 to June 2022 the Trustees worked through the process of becoming an Incorporated Charity, with the full support and guidance of Milbank LLC and, effective 1st July 2022 Tring Tornadoes Junior Sports Club became Tornadoes Sports Education & Leisure (TSEL). All assets of TTJSC transferred into TSEL. Tring Tornadoes Junior Sports Club is retained as a trading name of Tornadoes Sports Education & Leisure.

Financial review


The aim of the Trustees is to ensure that the club's core costs are supported by its sponsorship and membership income. As a club we do not aim to make a large profit, as we price our membership in line with expected costs

Reserves

Reserves are retained by the Charity as a contingency and to fund future projects. For example: Cow Lane changing room build (which received planning approval in August 2019). Surplus cash is invested in bank deposits to generate income to support the objectives of the club. The club's financial statements are presented with this Trustees report. The results are in line with the Management Committee expectations.

Independent examiner

The trustees have agreed to reappoint Damian Slevin as our independent examiner. Damian is a qualified Accountant, living locally in Aston Clinton. This report was approved by the trustees on 24th April 2023 and signed on its behalf.

1. Accounting policies

1.1. Basis of accounting

1.4. Incoming resources

Income resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are also applied to categories of income:

- Membership income is recognised in the year to which the annual membership relates.
- Grants, are recognised when received.
- Tour income is recognised when the events occur.
- Sponsorship income is recognised in the year in which it relates.

3. Sustained Netball participation at current full capacity whilst continuing to seek new playing locations in order to try and meet demand. The Netball section continues to grow, with waiting lists for all age groups. With the struggle to get more training and match facilities these lists continue to grow. We have numerous level 1 coaches and a level 2 coach, plus qualified umpires in the club.
4. Delivered opportunities for participation in Futsal for football players aged between 8-16 years with us having teams playing in futsal tournaments and leagues as well as the FA Futsal Cup.

5. Encouraged many players and volunteers to attend suitable training to teach football, netball and futsal with many obtaining recognised qualifications. These courses include child protection/safeguarding, emergency aid, referee, linesman, umpire as well as FA Level 1 and 2 and Futsal Level 1 qualifications.
6. Continued to link well with our local schools in Tring and the surrounding villages by providing free sports kit for both football and school netball teams. We continue to look add value to benefit both the school and club through hiring facilities and supporting school activities.


