Structure, governance and management

In the year 2022 there were 4 Trustees, who are also Officers of NALC (President, Treasurer and 2 Vice-Presidents). Zoom Meetings are held 4 or 5 times a year and are attended by the Officers and representatives of our affiliated groups. Additionally Executive Group meetings are held using the same platform. NALC had two paid staff until 31st August 2022. Since then all work has been done by volunteers and we rely on the efforts of laryngectomees and their carers for much of our work around the country by our affiliated groups.

Sadly two Trustees have passed away, A Smith in November 2022 and G. Tuck in January 2023.

Objectives and activities

NALC's purpose is to promote the rehabilitation of laryngectomees. It does this by providing information to patients and hospitals in a variety of forms such as printed booklets and DVDs. All the information is also available digitally on our website and YouTube channel. Our affiliated clubs work with patients in their locality providing peer support.

Achievements and performance

During 2022 our work continued to be affected by the Covid 19 pandemic. Only a few of our groups have returned to their usual programme of meetings. All NALC meetings have taken place using the Zoom platform. They have proven popular, especially those featuring a guest speaker, usually a clinician. We continue to work with over 50 hospital trusts and we have around 40 affiliated groups in the UK.

We produced 4 editions of our newsletter CLAN and each month there are around 1,200 streaming's of videos from our YouTube channel. Our information leaflets and newsletters are available for download from our website. We respond to many requests for patient emergency items like wristbands and car stickers. We have provided online presentations to tertiary education institutions as part of our education programme.

Achievements and performance (continued)

There have been three key developments during the year. We have managed the transition from having paid staff to using volunteers only. This was successful and we managed to continue all our usual activities supporting the laryngectomee community. We commissioned a new website to provide easier access for patients and their families to our information resources. NALC has played an important role in setting up a UK Head and Neck Cancer Coalition and our President is one of 5 Board members of the Community Interest Company that was formed to run it in the Autumn.

Financial review

In 2022 our income fell significantly and was less than half of that the previous year. Additionally it was significantly less than our expenditure. This led to our staff being made redundant to ensure we could meet all our financial obligations. Later in the year we received a grant from a Charitable trust that meant we ended the year with sufficient funds at our disposal. We are now in a stable situation where we are certain that our income will meet all our costs and are finally secure for some years ahead.

As the trustees of the charity you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').



General Committee Meetings are held 3 or 4 times a year and are attended by the Officers and representatives of our affiliated groups. An AGM is held, usually in May. NALC has two paid staff, based in our London office, but relies on the efforts of laryngectomees and their carers for much of our work around the country.

Objectives and activities

NALC's purpose is to promote the rehabilitation of laryngectomees. It does this by providing information to patients and hospitals in a variety of forms such as printed booklets and DVDs. All the information is also available digitally on our website and YouTube channel. Our affiliated clubs work with patients in their locality providing peer support.

Achievements and performance

During 2021 our work continued to be affected by the Covid 19 pandemic. All of our meetings have taken place using the Zoom platform. They have proven popular, especially those featuring a guest speaker, usually a clinician. We continue to work with over 50 hospital trusts and we have around 50 affiliated groups. Each month there are around 1,200 streaming's of videos from our YouTube channel and 1,500 leaflets and newsletters are downloaded from our website. Our office responds to many requests for patient emergency items like wristbands and car stickers. We have provided online presentations to tertiary education institutions and laryngectomee events organised by medical equipment manufacturers.

There have been two key developments during the year. Many laryngectomees contributed to a survey in late 2020 asking about their experiences of Covid. In 2021 NALC has worked with the clinicians responsible for the survey in analysing the results and disseminating the findings. Our President contributed to a presentation to the Royal college of Speech and Language Therapists annual conference and co-authored a published scientific paper. Late in 2021 NALC became involved in an initiative to set up a UK head and neck cancer coalition, working with other patient groups, research centre and leading clinicians.

Financial review

As in 2020 our income and expenditure were closely matched, both slightly lower than in the previous year. Our largest source of income was from charitable trusts, including further support from a trust that has supported us every year since 2017. Wandsworth Council provided grants as part of Government support during the continued Covid pandemic. Donations from the laryngectomee community remained well below 2019 levels due to the restrictions of social gatherings making fund raising events problematic.

The future outlook is causing concern. Our income continues to fall compared to previous years, we have limited reserves and promises of future support are few in number. We may reach the point where we have to drastically change how we deliver our services to the laryngectomee community. However the Trustees are very determined that NALC will continue to support laryngectomees as we have done since 1975.
