**Summary of the main achievements of the charity during the year**

Bonfire Night and Childrey Festival were once again our major fundraising events. The pavilion and playing field were also used for the annual village summer fete and was rented out on several occasions for parties, family gatherings and as a parking area for several weddings and other village events, including music events for the local churches.

During the year, some funds that were left over from the Coronation Tea were donated by the Parish Council to contribute to the purchase of a new gazebo which was required by the trust for events. It was agreed that the gazebo could be used by the village organisations and rented to villagers for a nominal sum for private events. This was rented twice during the year.

Routine maintenance to the field has continued with grass-cutting and weed control. The trust would like to thank the small group of villagers that are involved in the grass cutting rota using the trust sit-on mower (purchased last year) now that grass cutting is no longer provided by the parish council.

The playground's climbing net which was purchased towards the end of last financial year, was fitted in spring 2024 and one of the climbing frame posts was replaced. The infant swings were replaced and other minor playground repairs were carried out. The Trustees hope to update elements of the playground in due course.

Some of the old zip wire poles were repurposed to form a barrier to stop people driving on to the grass which damages the field. It is hoped that more work can be done on the driveway in 2025/26.

The football facilities continue to be hired during the year for football training by four teams from Wantage Town FC and one team from East Challow. The teams included children from the village therefore maintaining a strong link to local residents. There also continues to be regular use of the goals by families in the village.

The Trust continued to support Little Ducks preschool. Discussions remain on-going regarding the long-term position. The Trust feel it is important that they continue to offer their support for Little Ducks as a vital organisation within the village and for our primary school.

As reported last year, the Parish Council's decision to no longer support the playing field resulted in the Trust taking a proactive decision to purchase a new sit-on mower at the end of last financial year. As reported above, the trust relies on a small supportive group of villagers to cut the grass on a rota basis which the trust estimates saves it approximately £2,500 each year.

Although this was a sound economic decision, the purchase of the new mower did substantially impact the trust's available funds and delayed the upgrade of the playground for the local residents which was unfortunate.

The Trustees discussed with the Parish Council the possibility of an annual grant towards the upkeep of the playing field in light of its continued use and enjoyment by the local community, however funds were not forthcoming and it is with regret that the Trust believe that this

important historic link between the Parish Council and the Playing Field Trust has now come to an end.

The Trustees would like to acknowledge the continued generosity of volunteers, local residents and members of the trust who continue to support the Playing Field.

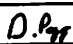

**Summary of the main achievements of the charity during the year**

This year saw another successful Bonfire Night and Childrey Festival as our major fundraising events. The pavilion and playing field were also used for the annual village summer fete as well as being rented out on several occasions for parties, family gatherings and as a parking area for several weddings and other village events, including music events for the local churches.

Routine maintenance to the field has continued with grass-cutting and pest control. The last of the current tree maintenance work was also undertaken which has been a significant cost of £4,300 over the last two financial years.

The zipwire reconstruction was successfully completed in spring 2023 with approval from ROSPA. This has been achieved by a lot of hard work from the trustees with the support of a broader group of Friends of the Playing Field. The final cost of the project was around £4,000 which was over £10,000 less than the quotes received to have the zipwire replaced by commercial suppliers.

A start has been made on some playground repairs such as the purchase of a replacement climbing net which cost over £1,000. It is hoped this will be fitted in the spring 2024. The trustees hope to update elements of the playground should available funds allow.

There have been some rudimentary improvement of the driveway and parking area but the planned repair work and the replacement of the pavilion's front guttering did not occur in the year due to the significant time involved with the zipwire replacement as well as the poor weather over autumn and winter. However, it is hoped these tasks may be scheduled for 2024/25.

Although the boys' and girls' football teams disbanded at the end of the 22/23 season, football continued at Childrey as the facilities were used by Wantage Town FC as a winter training ground. The teams included children from the village so the link to local residents remains strong.

The football training facilities were further improved with a replacement of the original halogen floodlights for LED floodlights thus improving lighting and reducing energy usage. There also continues to be regular use of the goals by families in the village.

The Trust continued to support Little Ducks preschool. Discussions remain on-going regarding the long-term position. The Trust feel it is important that they continue to offer their support for Little Ducks as a vital organisation within the village and for our school.

As with everyone, the cost of electricity continued to cause some concern through the year however energy costs significantly reduced towards the latter part of the year.

An unfortunate development arose towards the end of the financial year with the sudden announcement that the grass-cutting, which has long been provided by the Parish Council (custodian trustees), was to be withdrawn. The estimated cost to the charity of the withdrawal of this service is around £2,000. After some consideration, the Trustees purchased a significantly reduced sit-on mower for £5,250 and have formed a team of local residents to cut the grass on a rota basis.

The Parish Council's decision to no longer support the playing field has obviously impacted on the trust's available funds and may delay the upgrade of the playground for the local residents which is unfortunate. The Trustees hope to discuss with the Parish Council the possibility of an annual grant towards the upkeep of the playing field in light of its continued use and enjoyment by the community as outlined above.

We would like to thank Michael Chambers for his support in arranging the Vodafone matched funding for the various events we have organised over the years. Unfortunately, Vodafone announced that this year would be the last year that the scheme was operated. This is a loss of £1,000 per year to the trust.

The impact of the Parish council's decision and the loss of the Vodafone funding will impact the funds available to the trustees but we hope that the football training income and the ability to cut the grass ourselves will mitigate the loss of this income to a great extent.

The trustees would like to acknowledge the continued generosity of the volunteers, local residents and members of the trust who continue to support the Playing Field.

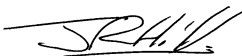

The Trust provides a sports field and pavilion for the use by Childrey and surrounding residents.

It also manages the playground on the field for the community.

The Trust also organises community events in the form of the annual Bonfire night and Music Festival.

The Playing Field is open to the public and the Trustees are aware of the Public Benefit requirement. This is taken into account when decisions are made. All decisions made are taken with the interest of the local community in mind.

The Trust relies on the hard work of a band of Trustees to help organise the fundraising events as well as undertaking maintenance work on the grounds.

**Summary of the main achievements of the charity during the year**

This year saw another successful Bonfire Night and Childrey Festival as our major fundraising events. The Playing Field also hosted a jubilee event for the village which was a wonderful way for the village to celebrate the Queen's Platinum Jubilee together.

Routine maintenance to the field has continued with rolling the pitches and grass cutting however there has also been substantial work done on replacing the zipwire where the main structure has now been erected with a view to completing the build in spring 2023. This has been achieved with the support of a broader group of Friends of the Playing Field. There was also a significant amount of tree maintenance work undertaken which will continue into 2023/24 financial year.

The improvement of the driveway and parking area and the replacement of the Pavilion's front guttering did not occur in the year due to the significant time and costs involved with the zipwire replacement and tree maintenance. However, it is hoped these tasks may be scheduled for 2023/24 or 2024/25.

The storage facility has largely been completed with work being supported by our DoE volunteers. Work on the storage area will continue with some internal insulation and shelving still to be added.

The boys' and girls' football teams completed another successful season however the boys' team will disband at the end of the season now they are of school-leaving age and the girls' team is moving to Wantage Town FC to be part of a bigger club. It is expected that football will continue at Childrey as the facilities will be used by Wantage Town FC as a training ground which will deliver additional income for the trust. There also continues to be regular use of the goals by families in the village.

The park has seen the continuation of Childrey Park Fitness through a dedicated group of supporters and the Trust continued to support Little Ducks preschool. Their Ofsted inspection of 2021 highlighted the requirement for more space which has now been achieved by the erection of a wooden outbuilding to the side of the pavilion. Planning permission was not required due to the temporary nature of the building.

As with everyone, the cost of electricity has caused some concern through the year however these have been minimised by switching to a smart meter and adopting a fixed rate contract which was supported by the Government's Energy Bill Relief Scheme.

As Co-Chairman, I would like to acknowledge the support of the volunteers and members of the trust who continue to support the Playing Field.
