CONDITIONS THAT SERVE TO PRESERVE, PROTECT AND IMPROVE QUALITY OF LIFE, INCLUDING THE SOUND ADMINISTRATION OF SUITABLE LAWS, REGULATIONS, LICENCES AND POLICIES;2. HIGH STANDARDS OF: PLANNING, URBAN DESIGN, LANDSCAPING, INFRASTRUCTURE AND TRANSPORT;3. CONSERVATION OF, CREATION OF, OR IMPROVEMENT TO: LANDS, BUILDINGS, OPEN SPACES, AMENITIES, FEATURES OF HISTORIC OR COMMUNITY INTEREST AND THE INDIVIDUAL CHARACTER OF AREA.4. AVOIDANCE, REMOVAL, OR IMPROVEMENT OF: FEATURES THAT ARE UNSIGHTLY, UNHEALTHY OR, IN THE PUBLIC INTEREST, UNDESIRABLE;5. A STABLE COMMUNITY, COMMUNITY INVOLVEMENT AND THE CAPACITY TO EFFECT CHANGE;6. A SENSE OF PUBLIC CONCERN FOR THE AREA;7. THE PRINCIPLES AND PRACTICE OF SUSTAINABLE DEVELOPMENT - BEING DEVELOPMENT WHICH MEETS THE NEEDS OF THE PRESENT WITHOUT COMPROMISING THE ABILITY OF FUTURE GENERATIONS TO MEET THEIR OWN NEEDS;8. KNOWLEDGE OF AND INTEREST IN THESE MATTERS AMONGST PERSONS CONCERNED IN A PROFESSIONAL, LEGISLATIVE OR ADMINISTRATIVE CAPACITY AND AMONGST OTHER PERSONS OR CORPORATE BODIES.
