During this reporting period the club due to Covid-19 restrictions including lockdown did not operate. It was not considered safe to do so for staff and the members wellbeing. We have no outdoor space for activities and with restrictions on the type of indoor activity allowed together with additional hygiene measures required it would not have been possible to operate safely.
