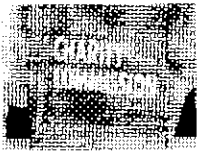

The opportunity was taken during closure to undertake some maintenance improvements to the building by way of improving the kitchen layout, toilets and the window frames. New chairs were purchased to replace the existing old ones.

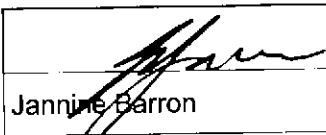

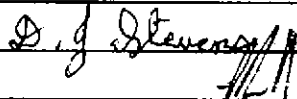
