TRUSTEES' ANNUAL REPORT FOR THE YEAR ENDING 5TH APRIL 2021

The trustees present their report along with financial statements of the charity for the year ended 5th April 2021. The financial statements have been prepared in accordance with the accounting policies set out in note 1 of the financial statements, complying with the charities constitution dated 25th April 1978 and amended on 1st February 1991 and 19th October 2010 applicable law and requirements of a statement of recommended practice, accounting and reporting by charities issued in March 2005. The financial statements are prepared in accordance with the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities" issued in March 2005.

The 2020-21 Accounts have been examined and approved as an accurate representation and review of our activities, fund raising and spend during this period.

TRUSTEES

Trustees in office during this period and of this report are set out on page 3.

FUND RAISING AND FINANCE

Income

During the year under review members, staff, friends and relatives of patients raised a total of £8,976 in a variety of different ways, including sponsorship events and donations in memory of patients who have sadly died. Normal fund raising activities were still severely curtailed by the impact of COVID restrictions. Investment income was £12,266 and the unrealised gain on the COIF Investment Fund was £78,150, giving a total income of £99,392.

Expenditure

The total expenditure for the year ending 5th April 2021 was £51,844. We spent a total of £40,129 on charitable activities, £7,505 on fund raising costs and governance costs of £4,211. This resulted in a year end surplus of £41,548.

When added to the funds balance brought forward at 6th April 2020 of £383,686 this left us with a funds balance at 5th April 2021 of £430,736.

The West London Kidney Patients' Association (WLKPA) is a charity representing patients suffering from kidney conditions or failure who are treated by the West London Renal Service, together with their carers, families and friends. It is one of the largest kidney patient associations in England, representing around 6,000 patients at any one time. It is run wholly by volunteers and has over 350 members. WLKPA works closely with the staff of the West London Renal and Transplant Centre, but is a completely independent body funded entirely by donations.

The WLKPA seeks:

- To support and as appropriate act as an advocate for individual renal patients in West London
- To maintain and improve the services provided for renal patients in West London
- To work with National bodies representing renal patients to secure appropriate recognition of their needs by the NHS and other parties.
- To advise and support the carers, families and friends of renal patients in West London

- To support research into the treatment and management of patients with renal disease and failure

First and foremost, we are on the patient's side. We will always seek to help any patient facing difficulties or problems as a result of their condition. This may be as simple as talking to them about what may be involved in dialysis or transplant or may involve working with the Renal staff to address particular problems and to make sure the patient gets the treatment and help they need. We are not medical experts and we cannot take the place of the medical team; but we are all renal patients ourselves, or have cared for someone with renal problems, and we have a lot of practical experience we are happy to share. We take part in dialysis and transplant conferences for patients and their carers and families; we produce newsletters and advice, for example on diet. And very occasionally we can help with small grants to meet patients' immediate needs. We also support patients participating in events such as the Transplant Games, the NKF conference and other renal related events.

In addition to pastoral and education support we also provide direct funding assistance in the form of purchase of equipment or materials for the Imperial Trust and associated units that endeavour to improve the patient experience during the course of their treatment. The funding is provided in response to requests made by both patients and Trust staff. The year ending 5th April 2021 saw a continuation of the reduced number of requests experienced in 2019/20, as a result of the pressures of COVID-19 on West London Renal Services.

Due to Covid-19, lockdowns, shielding and restrictions on meeting face to face meant we could not hold World Kidney Day and Organ Donation Week in person. We did however share the information on our Facebook page and on our website. The National Kidney Federation annual conference was also cancelled.

During the pandemic we continued to provide services. Our normal small capital grants were less significant but we continued to provide support to the very overworked and pressurised staff in the renal service, particularly through the provision of support for Christmas 2020, which contributed to their morale and hence the provision of a continuing excellent service to all renal patients.

We are always looking for volunteers and resources. We fully appreciate the devastating impact that renal failure can have on patients and those around them and we are always grateful to those who nevertheless are willing to support the WLKPA actively, whether through fundraising, support for patients, or as a trustee. The WLKPA provides a real opportunity to make a difference; not just for our own treatment and support, but for all those like us in West London and indeed across the country.

We would like to thank all members of the committee for their hard work and assistance in all our endeavours throughout the year and to the event volunteers who support us in all of our fund raising and awareness activities both at the hospital and in the wider community. We also would like to extend our gratitude to Professor Vassilios Papalois who has served in the role of Patron for the last 6 years. His support and encouragement across the Trust is greatly valued.



- to state whether particular matters have come to my attention.


Basis of independent examiner's report




NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 5TH APRIL 2021

1 Accounting Policies

(a) Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards. In preparing the financial statements the charity follows best practice as set out in the Statement of Recommended Practice (SORP) "accounting and Reporting by Charities".

(b) Incoming

Voluntary income including gifts, gift aid, donations, legacies and all other income are included in the year the charity is entitled to the resource and the amount can be measured reliably.

(c) Resources

Expenditure is summarised under functional headings on a direct cost basis. Irrecoverable VAT is included with the item of expenses to which it relates.

Charitable expenditure comprises those costs incurred by the association in the delivery of its activities and projects. The costs of generating funds are those costs incurred in attracting voluntary income. Governance costs include those incurred in the governance of the association and its assets and included any legal advice and all costs of complying with constitutional and statutory requirements.

(d) Fund Accounting

Restricted funds are subject to restrictions imposed by the donor. These are accounted for separately from unrestricted funds and details are provided in Note 6. Unrestricted funds are those that are not subject to restrictions, and any surpluses may be applied in furtherance of any of the organisation's objectives. Designated funds are unrestricted funds which have been set aside by the trustees for specific purposes. These funds may be released for general charitable purposes at the behest of the trustees.

(e) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost. Depreciation is calculated to write off the cost less estimated residual value of all tangible fixed assets in equal annual instalments over their estimated useful lives at the following rate:- Computer Equipment - 36 months.
