Management Committee members are elected on an annual basis at the Annual General Meeting. At an Extraordinary General Meeting held on 12th September 2001 it was agreed that the Annual General Meeting should be held within 20 weeks of the end of the financial year, which it was further agreed should become 30th April in each year.

Responsibilities of the Management Committee

The Management Committee, as Trustees of the group, are responsible under Charity Law for the preparation of financial statements which give a true and fair view of the state of affairs of the group and of the surplus or deficit of the group for the accounting period. In preparing the statements the committee is required to:-

- Select suitable accounting policies and apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Comply with applicable accounting standards

The Committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the group, and are responsible for taking reasonable steps for the prevention of fraud and other irregularities.

Objects, Organisation and Activities

The group was formed to further the education of the public, particularly young persons, in the art and science of music by the presentation of concerts and other activities. The orchestra has been in existence since 1959, whilst the choir was formed in 1964. The group is unusual in that it comprises of an orchestra and choir of over 200 members. Over the years the average age has increased, covering a wider range of ages, but still attracting members in their teens

Public Benefits

The trustees have paid due regard to guidance given by the Charity Commission on Public Benefit in deciding what activities the charity should undertake.

During a normal year, the activities undertaken to achieve the aims of the Group are -

- 3 Major Concerts each year involving the full Choir and Orchestra organised by the Group as ticketed events for the general public at venues with a typical capacity of 700 seats.
- 4 Community Concerts each year involving a small group of players and singers at events organised by other charities to help them raise funds for worthy causes.
- Music Study Days typically held once every 2 years to educate its members and others from similar musical organisations.
- UK or foreign Tours typically held every 3 years involving a small group performing a number of concerts over 3 days at selected venues and occasionally in conjunction with similar local organisations.
- Performances at Local Major Music Events run by other organisations.
- Our Bursary Scheme which supports members in furthering their musical education.

Review of progress and achievements

This was a year of great sadness for the Group as we lost our co-founder, Artistic Director and Conductor, Emeritus Professor Chris Green OBE.

Chris Green passed away on Friday 17th January 2025 whilst in hospital. He had suffered with his health in recent years, but his passing was a great shock to us all.

Chris co-founded the Trianon Orchestra in 1959 and, as the membership increased, a choir was formed in 1964. Since then Trianon has become the largest non-professional symphonic orchestra and choir in East Anglia, and a major presence in the regional music scene with three major concerts a year, a series of community-based concerts and bi-annual tours in the UK and Europe.

He was the group's Artistic Director and Principal Conductor throughout his life. He continued to take some rehearsals until December 2024 and conducted his last full concert in May 2024 with the sell-out audience raising an astonishing £1,820 for Save the Children. He leaves a huge legacy in his achievements with Trianon Music Group, Anglia Singers, Ipswich Arts Association and the many other groups and individuals he helped to succeed.

More importantly, Chris and Trianon played a hugely significant part in many people's lives and he leaves a great many people with a feast of happy memories.

Trianon is very grateful to the guest conductors who stepped forward to help us during this difficult year- Andrew Burke and James Davy.

In this financial year (2024/25) Trianon performed a full season of three main concerts plus four community concerts and hosted a music workshop on Poulenc's Gloria plus Rutter's mass of the Children.

Our first concert in Sept 2024 was at Snape Maltings concert hall. January 2025 saw us perform at Ipswich Corn Exchange, and in April 2025 we were extremely pleased to be welcomed back by Royal Hospital School, Holbrook to perform in their iconic Chapel.

All three concerts attracted good size audiences, positive feedback from reviewers and enabling support from the Friends of Trianon, Smith and Co Solicitors and the Royal Hospital School Holbrook.

The Group's membership lists currently stand at 101 choir (41 Sops, 29 Altos, 12 Tenors & 19 Bases) and 85 orchestra. Choir section numbers continue to raise concern because often members cannot commit to all concerts or rehearsals and therefore singers from other choirs are increasingly having to be called upon in order to meet the numbers required for a performance. The orchestra also has to manage the availability of players but in general has been successful in attracting new members.

The coming year will see us exploring new ideas for strengthening key sections. Failure to strengthen however will impact the scope of music the group can perform.

In addition to the main concerts, the Group received invitations to perform four Community Concerts in Suffolk, and each attracted good audiences who were generous at donating money towards their host's worthy causes.

Throughout the year the management team has continued to meet regularly (using videoconferencing) to ensure due diligence in the operations of the charity, and greater use is being made of emailed newsletters and the Group's website to keep members informed of activities. We continue to monitor and minimize the costs of issuing communications to members (Trianon News) and other administration costs, and this allows us to keep membership subscription rates amongst the lowest in the region.

Financial results for the year showed a net surplus of £3,260, compared with the net deficit of £3,322 in the previous year.

Major Concerts

Our September 2024 concert was titled 'Sea Fever' and performed at Snape Malting concert hall.

This concert was due to be conducted by Chris Green, and he completed many of the rehearsals before receiving medical advice that meant he had to step down.. Instead the Group was extremely grateful to Andrew Burke and James Davy who stepped forward to conduct the concert in Chris' absence.

The programme consisted of popular classics to celebrate the sea and those who provide lifeboat services across the United Kingdom. The soloist was Mark Saberton and the sponsors were Smith & Co Solicitors. The concert raised over £900 for the RNLI.

Ticket sales were just short of 600, and the concert recorded a surplus of £463.

In January we kicked off our 2025 season with a concert at the Ipswich Corn Exchange, sponsored by The Friends of Trianon and titled 'Trianon at the Cinema.

This concert was conducted by Andrew Burke and James Davy and the programme once again featured some of the great scores composed for films plus a strong emphasis on musicals.

This programme of familiar music attracted a good size audience and brought out a lively and confident performance by our players and singers.

Ticket sales totalled 426, slightly less than in the previous January, generating a surplus of £908.

Our spring concert in April 2025 was titled 'Trianon at the Royal Hospital School' and conducted by James Davy. This concert was dedicated to Chris Green following his passing a few months before. Chris had been very excited about Trianon returning to perform at the iconic venue of Holbrook Chapel and he was central to the previous year's planning of the programme which was specifically designed to exploit the Chancel's unique Acoustic and famous organ. The Royal Hospital School and their director of music Edward Allen, gave Trianon tremendous support to enable this concert. Trianon choir and orchestra were joined by members of the Anglia Singers and the Holbrook School Choristers for this performance. Janet Dann started the concert by addressing the large audience with a tribute and memories of Chris. It was a sunny afternoon, a fitting venue, and under James' baton it was an all-round excellent concert. Chris would have been very proud.

Ticket sales totalled 391, RHS did not charge a fee for hiring the venue on this occasion, resulting in the concert recording a surplus of £1,125.

Trianon subsequently gave a £300 donation to the RHS Charitable Trust.

Trianon in the Community

The Trianon in the Community programme continued to offer other charitable organisations the opportunity to raise funds for themselves through concerts given by singers and instrumentalists from the group.

Poulenc and Rutter Workshop

Following on from the great success of the previous year's workshop on Puccini's *Messa di Gloria*, Trianon hosted another half-day workshop in February 2025 on Poulenc's *Gloria* and Rutter's *Mass of the Children*.

The workshop was open to all, but was intended to be an introduction to the works that would be performed by Trianon later that year.

The day attracted just over 70 participant from a number of choirs and orchestra across East Anglia. The day was deemed a great success in both learning about the works and the composers, but also general networking between individuals and music groups. There was a net surplus of around £300 for the day.

Scholarship for School Age Students

One of the prime objectives of Trianon is to introduce and support young players and singers in their musical education and offer the experience of joining our symphony orchestra or choir to perform a wide variety of music at some cracking venues. For many years Trianon has operated a bursary scheme that offers financial awards to help members of any age with the costs of their musical education (full-time or short courses). To complement that scheme, we launched in May 2023 our scholarships for school age students. These scholarships will support any school-age student by funding their annual Trianon membership fee and allow them to participate in the full range of concert events.

Finances of the Group

The financial results for the year are shown in detail in the independently examined accounts which form part of this report.

The policy of the Management Committee is to cover the costs of concerts for each season from ticket sales and sponsorship, and to cover the cost of administration from subscriptions.

The accounts have been prepared under the Receipts and Payments method, which summarises bank transactions during the year.

The group remains financially strong.

The General fund showed an increase of £1,191 over the previous year, and the balance was over £25,000 at the year end.

Income (excluding concert income) included subs, programme advert income, a gift aid claim, donations received, some residual 60th anniversary book sales and bank and investment income. Subscriptions were kept at the 2023/24, rates.

Expenditure included Trianon News expenses, subscriptions, insurance, website, travel and other administration expenses. Storage costs were accrued, but none were paid during the year. 2 years' storage costs of £1,600 were paid in the 2023/24 year covering that and the previous year.

The Bursary fund showed a surplus in the year of £1,030. A transfer of £100 was made to the general fund to allow for school age members' subscriptions paid by the group. Income from investments was £605 and the value of the investments increased by £525.

The Tour Fund balance remained unchanged, after deferring fees received in advance for the tour scheduled for October 2025.

The Patrons Fund increased by £63 in the year, to £13,071. Friends subs income was £563, and the Friends sponsored the Jan 2025 concert with £500.

The Angela Chaplin fund increased by £976 interest received, to £22,960.

The balance sheet remains strong, with total funds of £100,085.

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the trustees for particular purposes.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal. There are no restricted funds at present.

The purpose of each of the designated funds is as follows:

Patrons' fund

The Patrons fund comprises subscriptions and donations from friends and patrons which are used for Special events and projects decided by the management committee.

Bursary funds

The capital fund generates income from investments which is used to provide bursaries to suitably qualified members to enable them to continue and develop musical education.

Tour fund

The tour fund is used to recover costs of overseas tours from those participating, or for expenditure incurred in hosting overseas music groups visiting on their tours. Any surplus will be used for general expenses of future tours.

Angela Chaplin fund

The Angela Chaplin fund was a bequest received in August 2012 from a former choir member. The group are actively seeking ways to spend this appropriately

Policy

In the Management Committee's view, the reserves should provide the group with adequate financial stability and the means for it to meet its charitable objectives for the foreseeable future.

Contingencies which may arise include last minute cancellation of major concerts (this occurred in January 2022 due to the Covid 19 pandemic, and in January 2010 due to bad weather), additional guest conductor's fees, storage costs, and the costs of replacing musical instruments.

The trustees have established a policy whereby unrestricted funds not already designated should represent at least 12 months of normal operational expenditure, or approximately £25,000 in the year to 30th April 2025.

At this level, the trustees are confident that the group would be able to carry on its activities in the event of a significant shortfall in income.

The trustees will review the amount of reserves required on a regular basis at management meetings.

Risk assessment

The Management Committee has not adopted a formal Risk Assessment Policy. It is considered that the main risk areas are:-

- (a) Public Liability claims arising from concert activities, and
- (b) Cancellation of concerts in respect of which commitments have been made.

Both of these areas are the subject of insurance arranged through Making Music, formerly known as The National Federation of Music Societies.

- (c) Loss of suitable and affordable venues.

The group is a member of Ipswich Arts Association which takes an active role in safeguarding the interests of the group and other groups with similar interests.

Investment Policies

The investments are regularly reviewed by the Chairperson and Treasurer. Cash fund surpluses are held in interest bearing accounts where appropriate.

Management Committee members are elected on an annual basis at the Annual General Meeting. At an Extraordinary General Meeting held on 12th September 2001 it was agreed that the Annual General Meeting should be held within 20 weeks of the end of the financial year, which it was further agreed should become 30th April in each year.

Responsibilities of the Management Committee

The Management Committee, as Trustees of the group, are responsible under Charity Law for the preparation of financial statements which give a true and fair view of the state of affairs of the group and of the surplus or deficit of the group for the accounting period. In preparing the statements the committee is required to:-

- Select suitable accounting policies and apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Comply with applicable accounting standards

The Committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the group, and are responsible for taking reasonable steps for the prevention of fraud and other irregularities.

Objects, Organisation and Activities

The group was formed to further the education of the public, particularly young persons, in the art and science of music by the presentation of concerts and other activities. The orchestra has been in existence since 1959, whilst the choir was formed in 1964. The group is unusual in that it comprises of an orchestra and choir of over 200 members. Over the years the average age has increased, covering a wider range of ages, but still attracting members in their teens

Public Benefits

The trustees have paid due regard to guidance given by the Charity Commission on Public Benefit in deciding what activities the charity should undertake.

During a normal year, the activities undertaken to achieve the aims of the Group are -

- 3 Major Concerts each year involving the full Choir and Orchestra organised by the Group as ticketed events for the general public at venues with a typical capacity of 700 seats.
- 4 Community Concerts each year involving a small group of players and singers at events organised by other charities to help them raise funds for worthy causes.
- Music Study Days typically held once every 2 years to educate its members and others from similar musical organisations.
- UK or foreign Tours typically held every 3 years involving a small group performing a number of concerts over 3 days at selected venues and occasionally in conjunction with similar local organisations.
- Performances at Local Major Music Events run by other organisations.
- Our Bursary Scheme which supports members in furthering their musical education.

Review of progress and achievements

In this year Trianon performed a full season of three main concerts plus three community concerts and hosted a music workshop on Puccini's *Messa di Gloria*.

The first two main concerts were performed in Sept 2023 and Jan 2024 at Ipswich Corn Exchange. The third was in April 2024 at St John's Church Cauldwell Hall Road, Ipswich.

All three concerts attracted positive feedback from reviewers and the Group attracted sponsorship for all three major concerts from Associated British Ports, Ipswich Rotary and the Friends of Trianon.

The membership lists currently stand at 95 choir (37 Sops, 28 Altos, 11 Tenors & 19 Bases) and 101 orchestra. Choir section numbers continue to raise concern because often members cannot commit to all concerts or rehearsals and therefore singers from other choirs are increasingly having to be called upon in order to meet the numbers required for a performance. The orchestra also has to manage the availability of players but in general has been successful in attracting new members.

The coming year will see us exploring new ideas for strengthening key sections. Failure to strengthen however will impact the scope of music the Group can perform.

In addition to the main concerts, the Group received invitations to perform three Community Concerts in Suffolk, and each attracted good audiences who were generous at denoting money towards their host's worthy causes.

Due to illness our Artistic Director Emeritus Professor Christopher Green OBE was unable to conduct our three main concerts, and we are extremely grateful to the conductors (listed later in this report) who willingly accepted our invitation to take up the baton.

Throughout the year the management team has continued to meet regularly (using videoconferencing) to ensure due diligence in the operation of the charity, and greater use is being made of emailed newsletters and the Group's website to keep members informed of activities. We continue to monitor and minimize the costs of issuing communications to members (Trianon News) and other administration costs, and this allows us to keep membership subscription rates amongst the lowest in the region.

Financial results for the year showed a net deficit of £3,322, as opposed to the adjusted net deficit of £1,221 in the previous year.

Major Concerts

Our September 2023 concert was titled 'The Gift of Music' and performed at Ipswich Corn Exchange. This concert was performed in celebration of Chris Green's 80th birthday year, but due to Chris being unwell, it was conducted by guest conductor Antoine Mitchell. The soloist was Margaret McDonald and the sponsors were ABP (Associated British Ports). The programme included music selected by Chris as having special significance to his life and ancestors. Music included:-

Ticket sales were lower than had been hoped for. This and guest conductor fees resulted in a net deficit of £3,170.

Our January 2024 concert was at the Ipswich Corn Exchange, sponsored by Rotary Ipswich and titled New Year's Musical Revels. This concert was conducted by Chandra Grover, Stephen Hogger and Andrew Burke.

The concert presented a light-hearted programme to welcome in the New Year, and the audience were presented with numerous hummable and singable tunes . The music included:-

This programme of familiar music brought out a lively and confident performance by our players and singers.

Ticket sales totalled 441 generating a surplus of £1,774.

Our spring concert in April 2024 was titled From Italy with love and conducted by guest conductor Stephen Rumsey. The venue for this concert was St John's Church Cauldwell Hall Road Ipswich and it was sponsored by the Friends of Trianon. The programme featured:-

This concert marked a welcome return after several years to a great performance venue, and it attracted a good size audience with 249 tickets sold, the best April concert attendance since 2019.

The concert recorded a deficit of £1,777, after accounting for guest conductor fees.

Trianon in the Community

The Trianon in the Community programme continued to offer other charitable organisations the opportunity to raise funds for themselves through concerts given by singers and instrumentalists from the group.

In this year Trianon performed three community concerts. The events were as follows:-

Furthermore, Trianon also took part in July 2024 in the annual Ipswich Music Day.

Puccini Workshop

In April 2024 Trianon hosted a workshop which explored Puccini's life plus an introduction to his *Messa di Gloria*, which was to be performed in Trianon's main mid-year concert later that same month. The day was open to all and attracted just over 60 participants from a number of choirs and orchestras from across East Anglia. The day was deemed a great success in both learning about Puccini, but also general networking between individuals and music groups, There was a net surplus of £127 for the day, and this was used to set off some of the April concert deficit.

Scholarship for School Age Students

One of the prime objectives of Trianon is to introduce and support young players and singers in their musical education and offer the experience of joining our symphony orchestra or choir to perform a wide variety of music at some cracking venues. For many years Trianon has operated a bursary scheme that offers financial awards to help members of any age with the costs of their musical education (full-time or short courses). To complement that scheme, we launched in May 2023 our scholarships for school age students. These scholarships will support any school-age student by funding their annual Trianon membership fee and allow them to participate in the full range of concert events.

Finances of the Group

The financial results for the year are shown in detail in the independently examined accounts which form part of this report.

The policy of the Management Committee is to cover the costs of concerts for each season from ticket sales and sponsorship, and to cover the cost of administration from subscriptions.

The accounts have been prepared under the Receipts and Payments method, which summaries bank transactions during the year.

The group remains financially strong, despite the deficit made during the year.

The General fund showed a decrease of £4,588 over the previous year, but the balance was still nearly £24,000 at the year end.

Income (excluding concert income) included subs, programme advert income, a gift aid claim, donations received, some residual 60th anniversary book sales and bank and investment income. Subscription rates were increased for 2023/24, resulting in over £300 additional income.

Expenditure included Trianon News expenses, subscriptions, insurance, website, travel and other administration expenses. Storage costs of £1,600 were paid during the year, covering this and the previous year. (None were paid in the 2022/23 year.)

The Bursary fund showed a surplus in the year of £402. No bursaries were paid during the year, income from investments was £541, but there was a decrease of £239 in the value of investments.

There was no movement in the Tour Fund during the year.

The Patrons Fund increased by £243 in the year, to £13,008. Friends subs income was £743, and the Friends sponsored the April 2024 concert with £500.

The Angela Chaplin fund increased by £622 interest received, to £21,984.

The balance sheet remains very strong, with total funds of £96,825..

The charity's reserves and its policy are set out as follows:

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Designated funds are unrestricted funds earmarked by the trustees for particular purposes.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal. There are no restricted funds at present.

The purpose of each of the designated funds is as follows:

Patrons' fund

The Patrons fund comprises subscriptions and donations from friends and patrons which are used for Special events and projects decided by the management committee.

Bursary funds

The capital fund generates income from investments which is used to provide bursaries to suitably qualified members to enable them to continue and develop musical education.

Tour fund

The tour fund is used to recover costs of overseas tours from those participating, or for expenditure incurred in hosting overseas music groups visiting on their tours. Any surplus will be used for general expenses of future tours.

Angela Chaplin fund

The Angela Chaplin fund was a bequest received in August 2012 from a former choir member. The group are actively seeking ways to spend this appropriately

Policy

In the Management Committee's view, the reserves should provide the group with adequate financial stability and the means for it to meet its charitable objectives for the foreseeable future.

Contingencies which may arise include last minute cancellation of major concerts (this occurred in January 2022 due to the Covid 19 pandemic, and in January 2010 due to bad weather), paying guest conductor's fees in the event of the Artistic Director's illness, storage costs (the current musical director does not charge for his services and provides storage for music and instruments at relatively low cost), and the costs of replacing musical instruments.

The trustees have established a policy whereby unrestricted funds not already designated should represent at least 12 months of normal operational expenditure, or approximately £24,000 in the year to 30th April 2024.

At this level, the trustees are confident that the group would be able to carry on its activities in the event of a significant shortfall in income.

The trustees will review the amount of reserves required on a regular basis at management meetings.

Risk assessment

The Management Committee has not adopted a formal Risk Assessment Policy. It is considered that the main risk areas are:-

- (a) Public Liability claims arising from concert activities, and
- (b) Cancellation of concerts in respect of which commitments have been made.

Both of these areas are the subject of insurance arranged through Making Music, formerly known as The National Federation of Music Societies.

- (c) Loss of suitable and affordable venues.

The group is a member of Ipswich Arts Association which takes an active role in safeguarding the interests of the group and other groups with similar interests.

Investment Policies

The investments are regularly reviewed by the Chairperson and Treasurer. Cash fund surpluses are held in interest bearing accounts where appropriate.
