During the year the Trustees made grants as shown in the Accounting Statement on page 2 to The Children of Lota Charitable Trust, a UK charity operating in Chile to relieve poverty and advance the welfare and education of children in the very poor district of Lota in Southern Chile. The Trustees will continue to support this cause and any other similar deserving causes, both national and international.


**Financial review**

The Accounting Statement on page 2 has been prepared on the receipts and payments basis in compliance with the appropriate legal requirements for a charity with a gross income not exceeding £250,000 and which is not a company incorporated under the Companies Acts. The Accounting Statement shows a deficit of receipts over payments of £10,140 (2024 surplus £10,427).

The reserves, which are represented by cash and investment assets as shown in the Accounting Statement on page 2, are held to provide income for the charity's activities as outlined above and will continue to be augmented in the future by loans from the Trustees when required or by distributions from other trusts as well as donations.
