Objects

a) The provision and maintenance of a museum in or near Egham, which, through its exhibitions, outreach programmes and use of its collections, aims to provide for the communities of Egham, Egham Hythe, Englefield Green, Thorpe and Virginia Water, a centre of life-long learning dedicated to raising awareness, sharing knowledge and promoting enjoyment of local history.

b) The provision of the above museum with facilities and a budget for its day-to-day operation, research and outreach activities, the continued improvement of its services and the extension, enhancement, conservation and storage of its collections for the continued enjoyment and benefit of the local community and visitors.

Trustees are elected from volunteers who have expressed an interest in the objects of the Trust. With a view to adopting best practice for charities, Trustees continued to commit themselves to attending external professional presentations on governance.

The Trust has been able to provide a home for its charitable activities because of a beneficial lease arrangement with Runnymede Borough Council, giving security of tenure.

Cllr. R.A. King served as Hon. Treasurer throughout the year and beyond, although having resigned, his role was taken over on a professional basis by Ms. M. Jenkins on 1st November, 2023.

Miss A.E. Stone served as Curator throughout the year although her contract was not renewed as at 1st January, 2024.

As at 23.59 on 31st December, 2022, the Trustees entered into a legal agreement being the 'Transfer of Charitable Undertaking from an unincorporated charity to its corporate successor' with its successor charity, The Egham Museum Trust, charity registration number 1198538, which had the legal effect of all of the former charity's assets and obligations being taken over by the latter charity, with physical transfer to the successor charity principally of chattel assets and the collections being deemed to have been effected then, but with the transfer of other assets and obligations unless otherwise paid, still remaining to be effected at the date of this report.

As a result, the former charity would have ceased all activities as at that moment and in due course, will be dissolved.

***Vision:** A museum for all, valued by our diverse local community and at the heart of our cultural lives.*

***Mission:** Through our collections, exhibitions and outreach programmes, we provide a centre of life-long learning that raises awareness, shares knowledge and promotes enjoyment of local history.*

Activities

The Museum collects, displays and cares for items of local interest relating to Egham, Egham Hythe, Englefield Green, Thorpe and Virginia Water. The Museum provides displays on subjects of local historical interest, with a programme of changing temporary exhibitions, events and an outreach programme, working with local community, educational organisations and groups. In addition, the Museum has a Facebook page, a Twitter feed, a YouTube Channel, an Instagram account, and a website plus project micro-sites.

The Museum is normally open 3 half days each week (Tuesdays, Thursdays and Saturday mornings) free of charge for the general public to view or to undertake research and study, all assisted by several volunteers, helping researchers in person or by correspondence. The Museum works closely with Egham-by-Runnymede Historical Society (a separate registered charity) to undertake research into matters of local historical interest.

In the interests of reducing the spread of Covid-19, the Museum was closed to the public and volunteers throughout January 2022. The Curator and volunteers continued to work remotely throughout the month.

Achievements

- Temporary exhibitions; Crowns, Commemoration and Community, Egham and the Empire and St Cuthbert's Primary School.
- 31,223 hits on the website
- Loaned painting to Tiny Traces exhibition at the Foundling Museum, London
- Supported volunteers through events like a Christmas Coffee morning, trip to the Foundling Museum and visit to Royal Holloway Archives and Picture Gallery.
- 10 group visits to the museum including St Jude's Primary School, Thorpe Lea Primary, Manorcroft Nurseries and 3 online sessions including Strode's College (Geography).
- Offsite Sessions at Thorpe Lea Primary, Hythe School, Rivermede Court Care Home.
- 1197 people reached through in person outreach activity in the local community
- St Cuthbert's Year Three Class returned for the 4th year for their annual museum takeover - this time on the theme of the Stone Age.
- Continued to support Royal Holloway students through teaching sessions and placements including a Public History MA visit, summer placement and collaborating on Oral History module which resulted in 6 oral histories being added to the museum collection.
- Attended Royal Holloway Volunteering Fair
- Supported researchers including local historians, subject specific interests (eg Lagonda), family history researchers
- Delivered talks including Staines U3A Archaeology Group and Spelthorne U3A Local History Group and Egham-by-Runnymede Historical Society
- Partnered with Home Instead and Royal Holloway on Jubilee Tea Dance
- Other events including Magna Carta Day, Reminiscence, Craft activities
- Ran National Oddity Championship for the 3rd year
- 'Recover Together' Audience Development Internship supported by Surrey County Council.
