The object of the charity is to apply all monies received by the Trustees both capital and income to or for the relief of the poor and needy or to or for such other charitable purpose, institution, society or object as the Club shall in duly constituted meeting from time to time direct. In order to achieve the object, the charity holds fund-raising events to raise sufficient funds to meet its budget. The Trustees have carefully considered and are able to confirm the adequacy of the charity's assets to fulfil its future obligations.

The attached financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards and the new statement of recommended practice "Accounting by Charities". Income is credited to the financial statements when received.

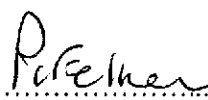
During the year the Trustees received donations and interest of £39,085 as shown in the attached statements. As a result, the charity has been able to make grants totalling £11,516 with the remaining reserves being carried forward for future projects. The unrestricted reserves at the end of the year were £26,887 and restricted £6,191.

As the funds raised are for short term projects the Trustees' investment policy is to place those funds on easy access deposit accounts giving current interest rates.

The Trustees' reserves policy is to maintain sufficient unrestricted funds to meet commitments for the following six months.

Applications for grants by the charity are considered by the appropriate Club committees and, if approved, are passed to Club Council for ratification. The Trustees then confirm that the proposed grant is within its objects and that there are sufficient funds before processing the payment.

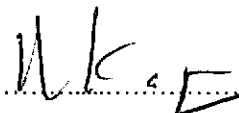

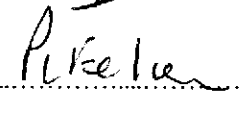

7 JOINT VENTURES

The club had two joint ventures during the year.

a) KIDSOUT

As the KidsOut accounting period differs from Kingston Rotary Club, in that it runs from 01/10/23 to 30/09/24, we are still to finalise our accounts for 2023/24, at the end of September.

So far this year, we have received subscriptions of £500 each from Surbiton and Kingston Rotary Clubs for the KidsOut day. For this year's KidsOut day on 12th June 2024, 474 children and 463 carers attended the event. Other guests included the Mayor of Kingston upon Thames, Rotarians and Inner Wheel members from Kingston and Surbiton, as well as representatives from the KidsOut national charity. After a ticket contribution of £10.00 for each child from the KidsOut national charity, we spent a total of just under £7,800 for the day. Besides entry tickets, this included the hire of two Mobiloos for Bedelsford and Woodlands schools, T-shirts and hire of four minibuses from RAKAT. This year, we were unable to hire as many minibuses as we required from RAKAT, due to a shortage of vehicles on the day. Children from King Athelstan school had to make their own way to Chessington World of Adventures on public transport.

For those children unable to attend the event, we donated £500 to Kingston Refugee Action and a further £500 to Elmbridge CAN.

The 100 Club is the main contributor to our funds and we will shortly be receiving the annual donation from that fund.

An outstanding donation of £250 for the KidsOut Toy Box scheme remains and will be used later this year via the Kingston Rotary Club Community & Environment Committee.

b) FIREWORKS

Together with Kingston Round Table No19, the Club organises a charity community firework display. There was no display in November 2020 or 2021 due to Covid restrictions. The display for November 2022 was cancelled ten days before the event due to a number of factors, but principally because of the withdrawal of support by the Police Events team and by the lack of support from the Royal Borough of Kingston Safety Advisory Group. There was no display in November 2023 for similar reasons.

Total income for the year was £ Nil (£ Nil - 2023) and there was no expenditure in this or the previous year.

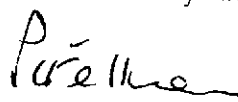

JOINT VENTURES

- 8 The Club had two joint ventures during the year.

a) KIDSOUT

The KidsOut accounting period differs from Kingston Rotary in that it commences from 1/10/22 to 30/9/23, so we are still to finalise our accounts for 2022/23. So far this year we received subscriptions from Surbiton and Kingston Rotary Clubs of £500 each for the KidsOut day. New Malden are no longer involved with the event. The 100 Club which is run by Chris Webster from New Malden Rotary, donated surplus funds of £9,000 which had accrued over the last couple of years. For this year's Kids Out day on the 14th of June 2023, 564 children, and 435 carers attended the event. Other guests included the mayor of Kingston upon Thames, Rotarians from Kingston and Surbiton, as well as Mike and Deborah Saxton. After a contribution from the Kids Out National charity, for each child attending, we spent a total of just under £7,000 for the day. This included the hire of two Mobiloos for Bedelsford and Woodlands schools, T-shirts and hire of ten minibuses from RAKAT. For those children unable to attend the event we donated £500 to Elmbridge CAN. We also donated £750 for the KidsOut Toy Box scheme. This was made to the Kingston Rotary Community and Environment committee to purchase toy boxes at Christmas 2022 for refugee children. Only £250 was used last Christmas, with the remaining £500 to be used Christmas 2023.

During the year, the Trust Fund received the sum of £50,000 from the estate of the late Sheila Saxton. The money was donated under a Deed of Variation entered into by Deborah Saxton and Michael Saxton, children of the deceased, with the express request that it be made available exclusively for the work of KidsOut. In order to comply with this request, the money was transferred immediately to the Kingston KidsOut Group. As this was an exceptional one-off receipt and payment, which do not affect the ordinary work of the Trust Fund, these are not recorded in the Trust's figures above.

b) FIREWORKS

Together with Kingston Round Table No19, the Club organises a charity community firework display. There was no display in November 2020 or 2021 due to Covid restrictions. The display for November 2022 was cancelled ten days before the event due to a number of factors but principally because of the withdrawal of support by the Police Events team and by the lack of support from the Royal Borough of Kingston Safety Advisory Group. Total income for the year was £ Nil (£ Nil - 2022), expenditure was £1,980 (£ Nil - 2021), giving a deficit for the year of £1,980 (£ Nil - 2022). It was agreed that £ Nil (£ Nil - 2022) would be donated to local charities.
