YEAR ENDED 30 JUNE 2025

The Committee presents this report and the financial statements of the Society for the year ended 30 June 2025, in accordance with the Charities Act 2011.

Establishment and objects

The Society is established as a registered charity under No. 278894. Its objects are to promote, improve, develop and maintain education in and appreciation of the art and science of music and in particular of choral music.

The Trustees have given due consideration to the Charity Commission's published guidance on the Public Benefit requirement under the Charities Act 2011. The main activities undertaken to further the Society's purposes for the public benefit in the period were the promotion and performance of choral music as described in the review of developments, activities and achievements section.

Structure, governance and management

The Society is governed by its constitution adopted on 10 October 1979, revised on 6 October 2010 and is managed by an Executive Committee consisting of elected Officers and other members. The Officers are elected annually by ballot at the Annual General Meeting. The Committee meets regularly during the concert season.

CHAIRMAN'S REPORT 2024-25

This year we are pleased to reflect on the 82nd Anniversary of Colchester Choral Society and once again I would like to thank all of our members and supporters for making this possible.

We started our 2024-25 concert season with our November performance of Mendelssohn's Elijah which was well presented especially given the absences and reduced numbers able to attend rehearsals. Kate Symmonds-Joy our alto soloist thanked us for 'an incredibly enjoyable Elijah' and thought the choir were superb, with a special mention to those from the choir who took on quartet parts. There were also many favourable comments from audience members and supporters.

Our thanks again go to Carla Hales, District Lead Tutor, who assisted with providing a Sing Up children's choir for the December Concert Here Comes Christmas, with Gillian Ward Russell on the organ and compered again by Liz Mullen of BBC Essex. A 'very well done' to the smaller choir who sang very well and the children who performed magnificently.

Our March concert started in an especially challenging way with many and prolonged difficulties in obtaining music, something we naturally take for granted for each concert. Our thanks go to our Librarian Mary for the determined and relentless efforts made to ensure we were able to sing despite the procurement delays. For this concert of Italian Baroque Music by Monteverdi, Bononcini, Carissimi & Vivaldi we are pleased to congratulate all the members of the choir who sang the solo parts with great confidence and assurance, resulting again in many favourable comments from the audience.

For our Summer Concert we travelled to Dedham's Assembly Rooms to perform English romantic songs, French songs and British folk songs. It was an incredibly hot day which made singing challenging, resulting in a performance that was spirited and expressive. It was also lovely to listen to Catherine Wood's flute playing which added another dimension to our concert. And the atmosphere and strawberries and cream were very enjoyable.

Other concerns that have been attended to by the Choir this year, and probably the most significant, has been the launch of a new website, moving from Making Music. The committee have also identified a requirement for a strategy shift to marketing, promotion of CCS, fund-raising & sponsorship. As part of this forward planning a Concert check list has been created to reduce time on discussing standard arrangements and enable us to consider the broader picture and the longer term needs of the Society.

The quote for rebranding and new web design was approved from Paul Hailes Design. The aims were to ensure clear concert details, marketing, choir ethos, ticket purchase confirmations and information updates on the new website, and subsequently remove the need for paper tickets to be posted out. In effect a clean clear modern website which is now up and running - our special thanks go to Mary and Ray who handled the bulk of this work with Paul.

We also decided on a more relaxed approach to Concert dress with men changing to black open necked shirts, with or without jackets, in line with current national trends.

We also have to report that the Independent Financial Examination is no longer a free audit and approval service going forward from Scrutton Bland. This was provided in memory of

David Foster a previous choir member and Treasurer. We thank them for their support over many years.

We have expressed our concern to the Council over redevelopment plans for part of Britannia car park behind St Botolph's and the potential implications with the loss of this facility for concert goers.

We are grateful to Matthew for organising a Fund-raising quiz in May, and have introduced a very successful post-concert social gathering at the Purple Dog on the Wednesday following the concerts.

Finally I would like to conclude my report by thanking all of our members for their commitment and efforts made to perform with such passion and skill and to continue to deliver a very high performance level.

Financial review

These accounts present the receipts and payments for the financial year ended 30 June 2025, alongside the 2024 comparatives, as well as a statement of assets and liabilities. Overall income from concerts, including sponsorship for the 2025 financial year was £9,256 (2024: £7,793). We are grateful to the efforts of choir members for their efforts in increasing audience numbers for our concerts, which were above budget for both our November and June concerts.

Total costs of staging concerts in the year were £17,751 (2024: £19,161).

Subscriptions income includes both choir member's subscriptions and subscriptions from the Friends of the Society. In addition to subscriptions income, we were also incredibly grateful to receive general donations totaling £5,962 (2024: £691). This included a significant one-off donation from a supporter of the Society. We are able to recover gift aid on eligible donations and a portion of our subscription fees, which once claimed will generate us an additional £2,747 in 2025 (2024: £1,250). Other income sources in 2025 include contributions by corporate patrons and fundraising and other receipts. Total income for the year was £31,346 (2024: £22,008).

The general costs of running the Society this year are consistent in their nature to last year's costs and the increase is largely due to inflationary cost increases, though we made a saving in insurance costs due to our lower income levels which will not be repeated next year. The Society is incredibly grateful to all its members and friends who give their time voluntarily in order to help keep the society's costs to a minimum.

Reserves policy

The society aims to maintain the accumulated fund at a minimum balance of £5,000. This level of reserves, in conjunction with the Society's insurance policy, would ensure that the Society could cover any concert abandonment costs should the need arise.

Reserves at the end of June 2025 (total assets less total liabilities) were £14,711, as a result of the surplus in the year. Although this is above the minimum required reserves balance of £5,000, this surplus was only achieved through the support of generous donors and the assistance of various friends and members in fundraising activities and the Committee are mindful of the long term financial stability of the choir when considering future expenditure and membership subscription levels.

Financial statements

The statutory financial statements of the Society are attached. They comprise a statement of receipts and payments, setting out the cash receipts and payments for the year, both from concert activities and from the Society's general activities. This analysis shows how dependent the Society is on the efforts of its members in providing funds to finance the deficit, which invariably arises in mounting concerts. The financial statements conclude with a statement of assets and liabilities summarising the Society's financial position.
