IN PROVIDING FOR THE SAID SCHOOL SUCH SPECIAL BENEFITS NOT NORMALLY PROVIDED BY THE LOCAL EDUCATION AUTHORITY AS MAY BE AGREED BETWEEN THE TRUSTEES AND THE MANAGERS OF THE SAID SCHOOL; 4. IN OR TOWARDS PROVIDING FOR ANY OTHER MAINTAINED SCHOOL SUBSTANTIALLY SERVING ADDERBURY SUCH SPECIAL BENEFITS NOT NORMALLY PROVIDED FOR THAT SCHOOL BY THE LOCAL EDUCATION AUTHORITY AS ARE AGREED BETWEEN THE TRUSTEES AND THE GOVERNORS OR MANAGERS OF THE SCHOOL CONCERNED.
