Trustees report for the year ending April 30th 2023

Objects

The society was established to promote the education of the public in all the arts by the presentation of performances and exhibitions.

It now limits its activities to the promotion of a variety of chamber music concerts by professional musicians of a national or international standard in the Newton Abbot area.

Activities

In the year to April 30th 2023 six concerts and a 75th Anniversary Piano Weekend were held at The Courtenay Centre, Newton Abbot.

Finance

Our 2022—23 programme of concerts was well supported and consequently our year to April 30th 2023 was very successful: the accounts show a surplus of £5,511. We cover our costs due to substantial sponsorship and ticket sales to local residents.

We hold reserves to cover the cost of replacing our piano in 5-6 years' time and our long term contract obligations to artists.

Currently, we hold some £13,000 in a unit linked charities investment fund, £30,000 in a short term charities deposit account and some £20,000 in a business bank account for day-to-day management of the charity's affairs.

Governance

The Society is an unincorporated association governed by a constitution adopted on its foundation in 1946 and the Officers and Committee are elected annually by the members in General Meeting
