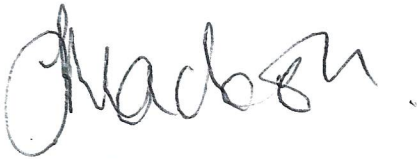

Independent Examination of Accounts 1/04/21 - 31/03/22

League of Friends

Bicester Community Hospital

1. Independent examination of accounts required due to income threshold exceeding £25,000 in relevant year.
2. There is no requirement for a full audit.
3. This organisation does not normally exceed the threshold, but a single income amount of £50,000 has created the need for an independent examination.
4. Examination carried out by Mrs S Mackrell MAAT. Relevant experience includes previously being the Responsible Finance Officer and Chief Officer for Bicester Town Council.
5. Review of records of League of Friends accounts shows no issues or concerns. They are conducted on an Income and Expenditure basis and consist of 6 payments and 4 income deposits for the whole year.
6. Review of bank accounts shows just one bank account held. Statements reconcile with annual accounts sheet.
7. There is one unusual item, consisting of a £50,000 bequest. This was received on 4/10/21 with no stipulations on its spending purpose.
8. **Conclusion. There are no areas of issue or concern.**
