THE PROVISION OF LECTURES AND OTHER FACILITIES FOR THE EDUCATION OF THE PUBLIC IN THE HISTORY OF THE TANDRIDGE DISTRICT AND OTHER PARTS OF EAST SURREY INCLUDING THE GEOLOGICAL AND ARCHAEOLOGICAL ORIGINS OF THE AREA, ITS SOCIAL, AGRICULTURAL, INDUSTRIAL, AND CULTURAL DEVELOPMENT AND ITS FLORA AND FAUNA.

**Activities:** The museum provides collections of objects and records illustrating the area, for examination and research by members of the public. It provides visits for and to schools for educational purposes and visits to organisations within the area to further knowledge of their district and its surroundings. The museum liaises with other museums and organisations within the County of Surrey.
