## **Trustee Annual report for Fleet and District Voluntary Care Scheme (Year ending March 2025)**

### **Objectives and activities**

As a charity formed in 1981, Fleet and District Voluntary Care Scheme (also known as Communicare), we offer transport assistance to residents of Fleet, Church Crookham, Crookham Village and Dogmersfield to medical appointments when no other means of transport is available. Our volunteers use their own cars for this purpose.

We are one of more than 110 similar groups in Hampshire who are supported by the Good Neighbours Network and are registered with the charity commission (reference number 283495).

The registered address of the charity is 35 Fir Tree Way, Fleet, Hampshire.

Trustees are nominated and voted in to the role at the annual general meeting.

### **Achievements and performance**

We have approximately 56 volunteer drivers and 24 Duty Officers and a current client base of circa 500. During the year we have recruited 20 new volunteers that have mainly replaced volunteers who have retired from Communicare.

In the year to March 2025, we have received a 20% increase in client requests for transport, which has meant that we have all had to work together to deliver the service level needed to meet local needs. We have driven approximately 500 clients to 2400 medical appointments covering a total of 34,800 miles. Our volunteers donated 6070 hours of their time to Communicare, either as drivers or Duty Officers, which is the equivalent of 759 working days.

As we deal with elderly and infirm clients safeguarding is an important part of our work. 35 clients were reported as safeguarding risks. This has included, gradual physical deterioration in long term clients, those struggling with mental health or increased confusion and those who are needing additional support beyond the suitability of our service. In response we have spoken and met with clients, shared concerns with family members and where it was appropriate, made referrals to Adult Services.

## Financial Performance


Annual donations as at March 31<sup>st</sup> 2025 were £25669. These came from client donations (£25373) and interest on a deposit account (£296). This shows a 9% increase in donations from last year (March 24) and a 40% increase on two years ago, which reflects the increased demand from our clients.

Total costs for the year were £28166, which is an increase of £7431. This resulted from driver expenses increasing by £2292, as a result of increased demand and a £5000 donation to GNN (Good Neighbours Network) who have supported us throughout the year. The donation was a result of the underlying surplus exceeding our requirement of funds at the end of the year as laid out by our reserve policy. The underlying surplus achieved in the year has also ensured that no changes have been required to suggested donations for a number of years.

We have continued to reinvest back into Communicare this year, for example lap top, printer, mobile phone, coffee mornings, gilets, driver aids, recruitment and ensuring Duty Officers are properly reimbursed for each rota.

There was a deficit for the financial year of £2496 loss after the £5000 donation to GNN (agreed at the AGM), which means the total funds, held predominantly in a current and a deposit account, amounts to £24142.

As a responsible going concern, we need to ensure that Communicare holds enough funds to cover any future one-off expenses or risks to us being able to operate. We have looked at the reserves needed and estimated a value that would cover future expenses we are likely to incur, such as a potential IT system to help with the increased volumes of calls we are receiving, potential electronic donation collection as the govt and banks move away from cash, risk of any future pandemic, and a general reserve to ensure we continue as a going concern.
