



1. Accounting Policies

Basis of Accounting:

The financial statements have been prepared in accordance with applicable accounting standards and under historical cost accounting rules.

Income and Expenditure Regulation:

All income and expenditure incurred is charged to the income and expenditure account on a cash accounting basis, adjusted for material accruals and prepayments.

2. Income this year

Total Income in 2023/24, excluding concert income, is estimated to be £16.8k, approximately 23% (£2.3k) higher than the prior year, mostly as a result of higher Subscription Income.

Scholarship programme funding was £3,900, with the Benefactor agreeing a £300 increase over the previous year. The Benefactor will continue to fund the Scholarship programme next year.

Net income from this year's four concerts was around £1k, a substantial reduction from last year's £2.6k, partly as a result of this year's support from the Hampstead Church Music Trust coming in the form of funding for the estimated deficits of our first two concerts of the year, rather than a donation which has previously allowed us to generate surpluses on concerts, as was the case particularly for our Spring concert in 2022-23, which was unusually profitable (£1.4k).

3. Expenditure

Total expenses, excluding concert expenses, were £15.3k, up by approximately 1% from last year.

Increased expenditure on our professionals, as well as higher fees payable to our umbrella organization, Making Music, and the need to have an

independent review of our accounts were partly offset by lower spending on the Scholars Programme (as no Tenor Scholar was found for this year) and savings on venue and music hire costs.

4. Future Commitments

The Scholarship scheme will continue next year. We have received assurances that funding will continue to be made available by an external funder in support of this programme.

5. Remuneration

No remuneration was paid to Trustees during the year.



Basis of Accounting:

The financial statements have been prepared in accordance with applicable accounting standards and under historical cost accounting rules.

Income and Expenditure Regulation:

2. Income this year

Total Income in 2023/24, excluding concert income, is estimated to be £16.8k, approximately 23% (£2.3k) higher than the prior year, mostly as a result of higher Subscription Income.
