REPORT of TRUSTEES for YEAR to 5 APRIL 2023

THE TRUST EXISTS for the benefit of or in future furtherance of such charitable purposes or Charitable foundations in England in such manner and in such proportions as the Trustees may from time to time in their discretion determine.

In the year to April 2023, the Trust made the second and third donations of a total pledge of £550,000 to King's College, Cambridge, in response to its Appeal. These two donations totalled £350,500. They were funded by incoming grants of £118,750 from the major donor, sales of investments of approximately £100,000 by Cazenove Capital, and cash at bank.

Ten other donations were made, totalling £17,000.

Expenditure for the year was £1,668, a decrease on the prior year's £2,528, as a result of lower professional and management fees.

As at the date of this report, the Trust had cash at bank of £85,924 and investments at Cazenove with a market value of £110,749.







REPORT of TRUSTEES
Year to 5 April 2022

The Trustees made 13 donations to charitable causes in the UK during the course of the year. Of these, eleven were in the range of £50 to £5,000. A donation of £12,000 was made to Classics for All. The largest donation was £200,000 to King's College, Cambridge, following the launch of the Appeal.

Income for the year was principally made up of donations received of £243,125.

The investment in M & G Charifund units having been sold, the investment funds are now managed by Cazenove Capital on an advisory basis with the investment objective of exceeding the rate of inflation. Total assets at the year end, including cash at bank, totalled £423,692 compared with the prior year £390,849.

The Trustees appointed Adam James Samuel Lyons as a fourth trustee after the year end, and he is a signatory to the accounts now submitted. These accounts have been audited by DJH Mitten Clarke Limited of Stoke on Trent, who continue to advise the Trustees on financial matters.
